

Professional Licensure Committee Meeting
May 24, 1988

The House Professional Licensure Committee met on Tuesday, May 24, 1988 at 10:35 a.m. in Room 418, Main Capitol.

The meeting was called to order by the Vice Chairman, Rep. William Lloyd. There were 24 members in attendance.

The first order of business was the consideration of Regulation 16A-180, Nursing Home Administrators Fee Schedule. After a brief explanation, Reps. Preston and Markosek made motions and the Regulation was approved unanimously.

Regulation 16A-182, Speech-Language and Hearing Examiners Fee Schedule was brought up for consideration. Reps. Pressman and Staback made motions and the Regulation was unanimously approved.

Rep. Lloyd called up for consideration Senate Bill 1176. Rep. Lloyd explained his amendment A-2399. Reps. Burd and Serafini made motions and the amendment was adopted by a vote of 23-1. Rep. Preston cast the only negative vote.

On the question of reporting the bill as amended, Reps. Burd and Saurman made the necessary motions and the bill was released by a vote of 23-1. Rep. Preston voted in the negative.

There being no further business for the day, the meeting was adjourned at 10:45 a.m.
