Senate Bill 902 - Printer's No. 1512


Senate Bill 902 is designed to amend Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes to provide an increase in the amount of pension for blind veterans from \$50 per month to \$100 per month, effective July 1, 1980.


