On January 4, 1974, Miss Carol Cochran, Director of Commission on Charitable Solicitations, advised that her staff is continuing to investigate the FOP lodges and other police-related agencies to include the professional solicitors involved. She has filed only one complaint as a result of the information this Committee previously furnished. The complaint involved the Fort Pitt Lodge, No. 1, along with the solicitor relating to that lodge. Miss Cochran made available two copies of the complaint which are being attached to this memorandum and are self-explanatory.

She has provided the Attorney General's Office with information regarding FOP, Lodge No. 91, as well as the Pennsylvania Chiefs of Police Association, however, to date, no complaint has been filed. She believes the Attorney General is waiting to see the developments in the Fort Pitt Lodge case before proceeding.

Miss Cochran advised that the State Police Civic Association filed appropriate papers with her organization for registration during the summer of 1973. The application was not approved at that time because it failed to contain all of the required data. She does not recall specifically, but believed that sometime after the disapproval of this application, Mr. Zinsky informed her that the State Police Civic Association was not going to solicit and, therefore, they were not going to pursue the registration. However, in November 1973, Mr. Zinsky forwarded to her office another application requesting approval for the State Police Civic Association. This request is set forth in a letter, dated October 25, 1973, which is being attached as part of this memorandum.

Miss Cochran said she replied to the second application by telling Mr. Zinsky that it could not be approved at this point because the annual report had not been properly completed. This disapproval is set forth in a letter, dated November 14, 1973, from Miss Cochran to the State Police Civic Association and is being attached as part of this memorandum.

According to Miss Cochran, the State Police Civic Association application has not been approved to date.

Also attached to this memorandum are letters dated August 8, 1973 from Zinsky to Miss Cochran, along with a letter, dated August 13, 1973, which contains a reply from Miss Cochran to Zinsky regarding the application.

It should be noted that Joseph T. Mullen, Special Agent, Pennsylvania Bureau of Investigation, Department of Justice, has been loaned to Miss Cochran to undertake investigations pertaining to the FOP lodges and others regarding registrations with the Charitable Solicitations Act.

Mr. Mullen came into the office this date and desired to have information that we have collected regarding Fraternal Order of Police, Lodge No.5. It was pointed out that such information could be made available at a later date; however, at the present time, certain areas of investigation pertinent to this Committee are pending and we, therefore, feel it inappropriate to divulge the information regarding FOP Lodge No. 5 at this time.

MOTION FOR A PRELIMINARY INJUNCTION

Pursuant to 10 P.S. § 160 et seq., Plaintiff, Commonwealth of Pennsylvania, by its Attorney General, Israel Packel, moves this Court for the equitable relief hereinafter set forth and in support of this Motion submits the following:

(1) Defendants, Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz, and J. O. Schwartz (sometimes hereinafter referred to as "the defendant solicitors") have solicited, are soliciting, and intend to solicit contributions on behalf of defendant, Fraternal Order of Police Fort-Pit Lodge No. 1 (sometimes hereinafter referred to as "Lodge No. 1"), and other charitable organizations without registering as professional solicitors with the Pennsylvania Department of State, without filing bond, and without filing copies of the solicitation contracts with the Pennsylvania Department of State all in violation of the Solicitation of Charitable Funds Act, ("the Act") 10 P.S. § 160 et seq.

- (2) In addition, the defendant solicitors have retained fees for solicitation services greatly in excess of the fifteen (15) percent allowed by the Act.
- (3) Defendant, Lodge No. 1 has solicited, is soliciting, and intends to solicit on its own behalf and has entered into contracts with professional solicitors without registering with the Department of State as required by the Act.
- (4) Defendant, Lodge No. 1 has incurred solicitation expenses in excess of the amount permitted by the Act and has agreed to pay and

did pay to professional solicitors, their agents, servants, or employees amounts greatly in excess of that allowed by the Act.

- (5) These solicitations in violation of the Act unless enjoined, will cause immediate and irreparable harm in that
 - (a) a considerable sum of money contributed by residents of Pennsylvania to charitable organizations, including Lodge No. 1, will be improperly charged as fees by the defendant solicitors.
 - (b) the acts of defendants which are complained of are in violation of laws of the Commonwealth.
- (6) The Plaintiff, Commonwealth of Pennsylvania has no remedy at law and, in fact, is empowered by the Act to seek equitable relief where it finds the Act has been violated.

WHEREFORE, pursuant to 10 P.S. § 160 et seq., plaintiff moves this Court:

- (a) to preliminarily enjoin and restrain defendants Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz their officers, agents, successors, servants and employees:
 - (1) pursuant to 10 P.S. § 160 et seq., from soliciting funds in the Commonwealth of Pennsylvania unless and until the defendant solicitors comply with all necessary

requirements of the Solicitation of Charitable Funds Act,

(2) from Soliciting funds in the Comm

- (2) from soliciting funds in the Commonwealth of Pennsylvania unless and until the defendant solicitors pay to the Fraternal Order of Police Fort-Pit Lodge No. 1 all monies collected for them by the defendant solicitors' solicitation activities, and
- (3) pursuant to 10 P.S. § 160 et seq., from transferring, concealing, encumbering, expending or dissipating in any way any monies collected by them on behalf of the aforesaid Fraternal Organization;
- (b) to order the defendant solicitors to file within fifteen (15) days with this Court an account of all monies collected by them on behalf of charitable organizations, including but not limited to the Fraternal Order of Police Fort-Pit No. 1, setting forth the amount of the solicitations per year and the amount paid the defendant solicitors by reason of said solicitations;
- (c) to enter judgment against the defendant solicitors in favor of the aforesaid Fraternal Order of Police Fort-Pit Lodge No. 1 in the full amount of all monies collected for that organization by the defendant solicitors, accomplished in violation of the Act;
- (d) to preliminarily enjoin and restrain defendants Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz, their officers, agents, successors, servants and employees:

(1) from soliciting funds in the Commonwealth of Pennsylvania unless and until the defendant solicitors pay to any charitable organizations for which they have solicited all monies collected for such organizations by the defendant solicitors' solicitation activities, and

- (2) pursuant to 10 P.S. § 160 et seq., from transferring, concealing, encumbering, expending or dissipating in any way any monies collected by them on behalf of the aforesaid charitable organizations;
- (e) to enter judgment against the defendant solicitors in favor of all charitable organizations for which they have solicited in the full amount of all monies collected for such organizations by the defendant solicitors, accomplished in violation of the Act; and
- (f) to preliminarily enjoin and restrain defendant Fraternal Order of Police, Fort-Pit Lodge No. 1, its officers, agents, successors, servants and employees:
 - (1) pursuant to 10 P.S. § 160 et seq., from soliciting contributions or having funds solicited on its behalf in the Commonwealth of Pennsylvania unless and until it complies with all the necessary requirements of the Solicitation of Charitable Funds Act.

Defendant, Frantz Advertising, Inc., its officers, agents, servants and employees are engaged in the business of acting as a professional solicitor for charitable organizations. Defendant, Arthur William Frantz, Century Building, Pittsburgh, Pennsylvania, is an individual engaged in the business of acting as a professional solicitor for charitable organizations and is a principal in defendant Frantz Advertising Inc. 5. Defendants, Lawrence Schwartz and J. O. Schwartz, 218 William Penn Hotel, Pittsburgh, Pennsylvania, are individuals engaged in the business of acting as a professional solicitors for charitable organizations. Defendants, Frnatz Advertising, Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz may hereinafter be referred to as "the defendant solicitors". Defendant, Fraternal Order of Police Fort-Pit Lodge No. 1 ("F.O.P."), 558 William Penn Hotel, Pittsburgh, Pennsylvania, is an unincorporated association composed principally of members of law enforcement agencies and is and holds itself out be be a benevolent organization which solicits funds from the public for charitable purposes. -2-

Defendants Frantz Advertising Inc. and Arthur William Frantz, their officers, agents, servants and employees have solicited, are soliciting and intend to solicit funds from the public which funds are to be used for charitable purposes or are to be used by organizations which spend such funds on charitable purposes.
- 10. Defendants Frantz Advertising Inc. and Arthur William Frantz have solicited, are soliciting and intend to solicit contributions from the public on behalf of the defendant F.O.P.
- 11. Defendants Frantz Advertising Inc. and Arthur William

 Frants have entered into contracts and intend to enter into

 contracts with charitable and benevolent organizations, including

 defendant F.O.P., and pursuant to said contracts defendants

 Frantz Advertising Inc. and Arthur William Frantz, their officers,

- (b) they have failed to post the \$10,000 bond required by the Act,
- (c) they have failed to file copies of their outstanding contracts to solicit funds with the Pennsylvania Department of State, and
- (d) they have retained or otherwise been paid fees for solicitation services greatly in excess of the fifteen (15) percent allowed by the Act.

COUNT II

- 13. Plaintiff hereby incorporates each and every allegation hereinabove alleged and hereinafter alleged as if fully set forth in this Count.
- 14. Defendants Lawrence Schwartz and J. O. Schwartz, their agents, servants and employees have solicted, are soliciting and intend to solicit funds from the public which funds are to be used for charitable purposes or are to be used by organizations which spend such funds on charitable purposes.
- 15. Defendants Lawrence Schwartz, J. O. Schwartz have solicited, are soliciting and intend to solicit contributions from the public on behalf of the defendant F.O.P.
- 16. Defendants Lawrence Schwartz and J. O. Schwartz have entered into contracts, and intend to enter into contracts with charitable and benevolent organizations, including defendant F.O.P. and pursuant to said contracts defendants Lawrence Schwartz and J. O. Schwartz, their agents, servants and employees engage in solicitation of funds from the public in

exchange for a percentage of the funds solicited. The percentage of funds solicited from the public which are retained by defendarts Lawrence Schwartz and J. O. Schwartz in some instances equals thirty-five (35%) percent of the funds solicited, with remaining sixty-five (65%) percent going to the charitable or benevolent organization. These contracts, if written, are not in the possession or control of the plaintiff and, therefore, are not attached hereto.

- 17. Defendants Lawrence Schwartz and J. O. Schwartz have violated, are violating and intend to violate, unless enjoined, the Solicitation of Charitable Funds Act in that:
 - (a) they have failed to register with the Pennsylvania Department of State as professional solicitors,
 - (b) they have failed to post the \$10,000 bond required by the Act,
 - (c) they have failed to file copies of their outstanding contracts to solicit funds with the Pennsylvania Department of State, and
 - (d) they have retained or otherwise been paid fees for solicitation services greatly in excess of fifteen (15%) percent allowed by the Act.

COUNT III

- 18. Plaintiff hereby incorporated each and every allegation hereinabove alleged and hereinafter alleged as if fully set forth in this Court.
- 19. Defendant Fraternal Order of Police, Fort-Pit Lodge No. 1 has solicited, is soliciting and intends to solicit contributions on its own behalf within this Commonwealth which funds are to be used for charitable and other public purposes. In connection with such activities, defendant Fraternal Order of Police, Fort-Pit Lodge No. 1 has incurred

substantial expenses, amounting to in excess of thirty-five (35%) percent of funds solicited.

- No. 1 has entered into contracts with professional solicitors, including the defendant solicitors, and pursuant to these contracts the aforesaid solicitors solicit funds from the public on behalf of defendant Fraternal Order of Police Fort-Pit Lodge No. 1 in exchange for a percentage of the funds solicited. The percentage of the funds solicited from the public which are paid defendant Fraternal Order of Police, Fort-Pit Lodge No. 1 to the professional solicitors in some cases equals 70% of the funds solicited with the remaining 30% going to the defendant Fraternal Order of Police Fort-Pit Lodge No. 1. These contracts, if written, are not in the possession or control of the Plaintiff and therefore are not attached hereto.
- 21. Defendant Fraternal Order of Police, Fort-Pit Lodge No. 1 has violated, is violating and intends to violate, unless enjoined, the Solicitation of Charitable Funds Act in that:
 - (a) it has failed to register with the Pennsylvania Department of State as a charitable organization,
 - (b) it has incurred solicitation and fund raising expenses in excess of thirty-five (35%) percent of total monies, pledges and other property raised or received by it by reason of solicitation, gift and fund-raising activities, and
 - (c) it has agreed to pay and did pay to professional solicitors or their agents, servants or employees, in the aggregate a total amount in excess of fifteen (15%) percent of the total monies

pledges, and other property raised or received by reason of any solicitation activities or campaigns.

WHEREFORE, plaintiff respectfully requests:

- (a) that this Court preliminarily, and permanently thereafter, enjoin and restrain the defendants, Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz, their officers, agents, successors, servants and employees:
 - (1) from soliciting funds in the Commonwealth of Pennsylvania unless and until the defendant solicitors comply with all necessary requirements of the Solicitation of Charitable Funds Act,
 - (2) from soliciting funds in the

 Commonwealth of Pennsylvania unless and

 until the defendant solicitors pay to

 the Fraternal Order of Police Fort-Pitt

 Lodge No. 1 all monies collected for

 them by the defendant solicitors' solicita
 tion activities, and
 - (3) pursuant to 10 P.S. § 160 et seq., from transferring, concealing, encumbering, expending or dissipating in any way any monies collected by them on behalf of the Fraternal Order of Police Fort-Pitt Lodge No. 1;
- (b) that this Court order the defendants, Frantz

 Advertising Inc., Arthur William Frantz, Lawrence

 Schwartz and J. O. Schwartz, to file within fifteen

Schwartz in favor of the Fraternal Order of Police Fort-Pitt Lodge No. 1 in the full amount of all monies collected for that organization by the defendant solicitors, accomplished in violation of the Act,
- (d) that this Court preliminarily, and permanently thereafter, enjoin and restrain the defendants, Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz, their officers, agents, successors, servants and employees:
 - (1) from soliciting funds in the Commonwealth of Pennsylvania unless and until the defendant solicitors pay to those charitable organizations for which they have solicited all monies collected for such organizations by the defendant solicitors' solicitation activities, and
 - (2) pursuant to 10 P.S. § 160 et seq., from transferring, concealing, encumbering, expending or dissipating in any way any monies collected by them on behalf of any charitable organizations;

(e) that this Court enter judgment against defendants, Frantz Advertising Inc., Arthur William Frantz, Lawrence Schwartz and J. O. Schwartz, in favor of any charitable organizations for which they have solicited in the full amount of all monies collected for such organizations by the defendant solicitors, accomplished in violation of the Act;

- (f) that this Court preliminarily and permanently thereafter, enjoin and restrain the defendant, Fraternal Order of Police Fort-Pit

 Lodge No. 1, its officers, agents, successors, servants and employees from soliciting contributions or having funds solicited on its behalf in the Commonwealth of Pennsylvania unless and until the defendant complies with all necessary requirements of the Solicitation of Charitable Funds Act, pursuant to 10 P.S. § 160 et seq.; and
- (g) that this Court grant such other relief as this Court deems necessary, proper and just.
