FILE: OPERATION "FUN"

With reference to efforts to obtain information at Corning Glass, Charleroi, Pennsylvania, it is noted that none of the officials were available on the first occasion that contact was made with this company.

On the next occasion, June 29, 1973, Patrick McCullough, Production Superintendent, was interviewed. He advised that he had some knowledge of the contributions that had been made to various requests, but this should be cleared directly with Plant Manager Robert Shepard who was not available.

Shepard was interviewed on July 9, 1973, at which time he advised he would look into the matter thoroughly and telephonically furnish the name of the individual who would appear in answer to the subpoena for testimony before the Committee on July 12 in Pittsburgh.

It was noted that Donald M. Hopkins would appear for testimony as indicated above.
