



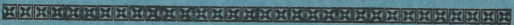

Section 495. Minors' Identification Cards; Licensees Saved From Prosecution.—(a) The statement of registration signed and issued to any registered elector by a Registrar, Commissioner or Clerk under the provisions of any permanent personal registration law of this Commonwealth shall, for the purpose of this act, be and accepted as an identification card. (b) Such identification card shall be presented by the holder thereof upon request of any State Liquor Store or any licensee, or the servant, agent or employee thereof, for the purpose of aiding such store, licensee, or the servant, agent or employee to determine whether or not such person is twenty-one years of age and upwards when such person desires alcoholic beverage at a State Liquor Store or licensed establishment.

ANYONE VIOLATING THIS PENNSYLVANIA LAW IS SUBJECT TO A \$100.00 FINE AND THIRTY DAYS IMPRISONMENT.

SHOPLIFTING LAW

SECTION 816.1 SHOPLIFTING

(a) Whoever shall willfully take possession of any goods, wares or merchandise offered for sale by any store or other mercantile establishment, with the intention of converting the same to his own use without paying the purchase price thereof, shall be guilty of shoplifting, and, upon conviction thereof in a summary proceeding, shall be sentenced to pay a fine of not less than twenty-five dollars (\$25) and not more than fifty dollars (\$50), or to undergo imprisonment of not less than five (5) days and not more than ten (10) days, or both.

(b) Any person willfully concealing unpurchased goods or merchandise of any store or other mercantile establishment . . . may be detained, in a reasonable manner and for a reasonable length of time, by a peace officer or a merchant or a merchant's employee in order that recovery of such goods may be effected. Such detention by a peace officer, merchant or a merchant's employee shall not render such peace officer, merchant or merchant's employee, criminally or civilly, liable for false arrest, false imprisonment or unlawful detention.

FOR APPLICATION OF FACE UP OR SLIDE OFF DECALS

Dip decal in tepid water, wait a moment, when image moves freely, wet surface and slide decal slightly over edge of paper.

Place this over-hanging edge in position on object and draw backing paper out from under decal.

Roll or work out wrinkles or air bubbles toward edge with a stiff cardboard, rubber roller, or damp cloth. Rinse decal with clear water and dry.

FOR APPLICATION OF WINDOW DECALS

CAUTION—Do not apply in freezing weather.

1. Be sure window is thoroughly cleaned and free of grease, oil, etc.
2. Dip transfer in water for a few seconds making sure the entire face and back is thoroughly soaked. **CAUTION**—Water must not be too cold as it will chill the film (body temperature is all right).
3. Wet the spot where the decal will be applied. Place the printed side directly on the glass.
4. Place transfer in position and work out wrinkles or air bubbles from the center toward edges with a squeegee or stiff cardboard.
5. Slide or peel paper backing away and repeat squeegeeing as in No. 3. At this time we recommend using a small (3") squeegee to firmly press decal into perfect contact with glass especially around edges.
6. Wash back of sign with plenty of clean water and sponge removing all gum, then dry back of sign and surface around it with chamois or dry cloth. **CAUTION**—This is important! If gum is not thoroughly washed off, it will dry quickly and cause the transfer to blister and curl up on edges. Also, if the decal is not thoroughly dried, water may soak back under edges and cause release or curling later.

IMPORTANT—Be sure and follow directions especially Paragraph 6.
