On March 20, 1974, I telephonically contacted Miss Carol Cochran, Director of the Commission on Charitable Solicitations (telephone No. 783-1720), and she furnished the following information:

- 1. A hearing was held on January 21 or 28 concerning Lodge #91 as to whether the Lodge has to register with the Commission.
- 2. The attorney for FOP Lodge #5, ANTHONY J. PIRILLO, acknowledged Miss Cochran's letter of August 2, 1973 indicating that the members of the Lodge were out of town for a convention and asked for an extension of two weeks. Since then she has heard nothing from the Lodge.
- 3. The Attorney General's Office has advised that until the suit against FOP Lodge #91 is settled, there is no reason to proceed against the other lodges in the state.
- 4. Several FOP Lodges have come forward and attempted to register; however, because of the above advice from the Attorney General's Office, those applications are being held in abeyance.
- 5. Miss Cochran has heard nothing further from the State Police Civic Association since her letter of November 14, 1973 advising that the information furnished in the State Police Civic Association letter of October 25, 1973 was inadequate.

On March 27, 1974, the following individuals were interviewed at The Franklin Mint, Inc., Franklin Center, Pennsylvania, 215:GL9-6000: DONALD S. WINGARD, Secretary and Assistant General Counsel (215:459-6106); DAVID BROWN, Communications; SHIRLEY M. JOHNSON, Editorial Assistant, Communications; and another individual whose name was not recorded and who was there for only a part of the interview.

The company is an independent publicly-owned corporation, not affiliated with the U.S. Government in any way.

Mrs. Johnson remembers seeing the FOP #5 Yearbook when it arrived three or four days prior to the interview, however, it was immediately discarded because it was of no value. She is in charge of maintaining records relating to payments or contributions to outside organizations. She made available the attached list of contributions made in 1973 and 1974 to date to police and related organizations.

None of the people interviewed could tell exactly how the contributions were originally initiated. They are all relatively new employees in their jobs, however, they are basically considered as institutional advertising to promote building tours of The Franklin Mint. If a contribution was relatively small and it had been made in the prior year, it would have been budgeted for in subsequent years and paid with very little scrutiny; however, requests for new contributions are looked at more closely.

Several of the individuals talked to had FOP dance and show tickets for the May, 1974 performance, however, they did not know exactly how they had been received at the company. They were paid for by private payments, not by corporation funds.

On March 26, 1974, Mr. WILLIAM A. PETERSON, President, Better Business Bureau of Eastern Pennsylvania, 1218 Chestnut Street, Philadelphia, Pennsylvania, telephone 215:WA3-7636, was contacted and said the BBB would cooperate in every way possible. He said that Mrs. Taylor would be the most knowledgeable employee concerning contributions and related problems in the area.

Mrs. LUCIE TAYLOR, Secretary of the corporation and manager of the Solicitations Division, telephone 215:WA3-1547, was contacted and made available the following items from her files:

- 1. A sample letter sent by BBB to each new member.
- Correspondence in 1968 between BBB and the Philadelphia Police Department concerning solicitations by the Police Home Association (FOP #5) wherein it was indicated that one of the solicitors identified himself as Sgt. McLAUGHLIN.
- 3. 1971 correspondence from BBB of Greater Milwaukee relating to solicitation of ALLEN BRADLEY of Milwaukee, Wisconsin, on behalf of the Police Home Association, Lodge #5.
- 4. A sample letter and a current questionnaire which is sent to fund raisers when the BBB attempts to obtain information concerning certain solicitations. This is the type of correspondence which was sent to the Philadelphia Police Home Association on November 9, 1971 in connection with the above inquiry from Milwaukee. As indicated in the foregoing correspondence, a second request was sent to the Home Association on November 29, 1971 and again on December 13, 1971. Information was never received by BBB from the Home Association.

- 5. February 1971 correspondence from Willow Grove Federal Savings and Loan Association of Willow Grove, Pennsylvania, concerning solicitation by the Home Association.
- 6. March 1972 correspondence from Task Force in Philadelphia, Pennsylvania, concerning solicitation by the Home Association.
- 7. April 1972 correspondence from Continental Imports, Inc. concerning solicitations on behalf of the Home Association.
- 8. Correspondence from The Peasant Shop of Bryn Mawr, Pennsylvania, dated May 1, 1972, concerning solicitations on behalf of the Home Association.
- A note by Mrs. Taylor, dated June 1973, concerning tickets for the Miller-Johnson Circus in which she discussed the item with JOE PINTO of FOP, Lodge [#]5.

Mrs. Taylor indicates that her office receives inquiries or complaints daily concerning all types of solicitations. The BBB furnishes such information as it has to its members and the public, however, BBB does not recommend whether a contribution should be made or whether it should not be made, neither does it maintain a blacklist of organizations or solicitations it does not favor.

Mrs. Taylor advised that the BBB desires full disclosure concerning the method of solicitation, by whom, income and expenditures, so that such facts can be made available to those individuals desiring it. Such individuals can then make a determination whether they want to contribute or not to contribute to a particular cause.

On March 26, 1974, Mr. JAMES E. HAMBLEN, Treasurer, and WILLIAM RENNIE, Vice President and member of the Board of Directors, were contacted at Smith, Kline and French Laboratories, 1500 Spring Garden Street, Philadelphia, and suggested that Miss Engates would be the proper individual to talk to concerning corporate solicitations.

Miss JANE ENGATES, Manager, Information Service, Public Affairs, telephone 215:LO4-2400, Ext. 371, advised that she has handled contributions and payments to groups in the Philadelphia area. She is not responsible for corporation payments to large foundations, i.e. 501 (c) 3 groups.

The corporation will not make payments to individuals calling at corporate headquarters and desiring to pick up a check or money at the door. If such a phone call is received, the person calling is informed to send in their request and it would be considered. If the request is approved, the payment would be transmitted through the mails to the organization desiring a contribution.

Miss Engates remembers receiving the FOP, Lodge #5 Yearbook three or four days ago. Since it was meaningless for their purposes, it was thrown away immediately.

She made available copies of records (attached) which reflect payments during the past several years to the following police or police related groups:

The corporation does not know the extent to which the foregoing associations use professional fund raisers, nor do they have any idea as to how the money is spent. This foregoing generalization does not refer to Items 7 and 8 above because corporation representatives are knowledgeable of the PAL activities and have visited their clubhouse and participated in other ways in the organization's activities.

Mr. ANTHONY KARLVINCE was interviewed on March 26 at his place of business, Keystone Fidelity Publications, 2015 East Allegheny Avenue, Philadelphia, telephone 215:GA6-1600. He furnished the following information.

At one time, probably in 1964, 1965 or 1966, he had a contract with FOP, Lodge #5, however, he does not know where that contract now is. He operates on a verbal basis. In the original contract, he received 40% of all solicitations. He could not operate at a profit; and about two, three or four years ago, his share of solicitations was upped to 55%.

He solicits for the FOP official yearbook pretty much the year round. The FOP arranges and pays for the printing of the book. He believes that they get upwards of 600 copies, many of which is mailed by Karlvince to the larger and better firms advertising in the book. He knows of no use to which the book can be put.

His company is a Pennsylvania corporation, not registered under the Charitable Solicitations Act in the state. His attorney, JERRI BLOCHE, a number of years ago said the Act was not applicable to Karlvince's operations. FOP, Lodge [#]5 also checked this out and agree.

Mr. Karlvince maintains a record of prior year contributions and this record is a source of solicitation in the following year. He estimates that 35% to 40% of the prior year's business develops into repeat business. Yellow Pages are the No. 1 source of new business, however, he does use other mailing lists as they become available.

Each year in November or December, he sends out a notice to last year's contributors with the hope that he will get repeat business. Any contribution paid for is addressed to FOP, Lodge ^{#5} at their Spring Garden address.

He has four girls helping in his office. In addition, he has seven solicitors and himself. He pays FICA taxes on himself and the four girls. The solicitors are considered independent contractors. They get 20% commission.

Follow-ups are made in about sixty days if there is no reply from the original solicitation. The solicitors get 25% of any business they get from their own sources. Calls are only made to business firms, not to individuals and the general public.

After the Lodge receives the funds from the contributors, they make a deposit and, on a weekly basis, give Mr. Karlvince a check for 55% of the week's deposits.

On occasion, one of his staff may go to a particular business to explain the program and collect money after a sale. This is in instances where a particular businessman wants to know more about the program. Normally, he does not send collectors out for the money.

He has a large variety of posters and other publicity material which he uses in the program. Copies were furnished and are attached.

Some people are solicited, such as attorneys, doctors, and architects, who make a contribution but do not desire advertising in the yearbook because of professional ethics. Those desiring advertising in the yearbook send proposed copy of the ad to FOP, Lodge #5 which, in turn, gives it to Keystone who makes the final copy of the ad for the yearbook. FOP, Lodge #5 selects the printer.

Mr. Karlvince also solicits for the following organizations:

- 1. Philadelphia Police, Firemen, and Park Police.
- 2. Disabled American Veterans.
- 3. Delaware County Police and Firemen.
- 4. Union Labor News, which is a Keystone quarterly publication.
- 5. Constables Association of Pennsylvania.

Mr. Karlvince has to pay for all postage, solicitation envelopes, receipts, promotional material, telephone, office supplies and other expenses.

The building which Mr. Karlvince occupies was purchased and renovated by him. It has no street address or other identity on the front door. It is a three-story building. The top floor is living quarters. The first floor has his small personal office and "bullpen" type of clerical operation. The basement is divided into two rooms from which the solicitors operate.

On March 25, Mr. DONALD D. SLONE was interviewed at FOP, Lodge #5 premises where he maintains an office. Mr. Slone said he resides at **Marking**

He also resides at telephone number at FOP, Lodge #5 is 215:WA3-7680.

His company is the Don Slone Public Relations, Inc., a Pennsylvania state corporation.

He is a consultant to LARRY SWARTZ, 218 William Penn Hotel, Pittsburgh, Pennsylvania. Swartz does the solicitation for the Pittsburgh Police Show and Dance, and Slone works on the program for that affair. JULES SWARTZ, a brother of Larry Swartz, used to have the FOP, Lodge #5 Show and Dance solicitation. It was known as the Dale Swartz Associates. Slone has been with this program about eight years. When Jules Swartz died about 2-1/2 years ago, he became the boss of the operation.

To his knowledge, there was never a written contract with FOP, Lodge #5 regarding this solicitation. The split used to be 50/50, but three years ago the solicitor was raised to 55%.

The Show and Dance is put on in May of each year in Philadelphia. Tickets are \$5.00 for two people. Each year about October, Slone starts to solicit for the sale of tickets for the following May show. He solicits the public for tickets, principally business people.

He also solicits for the Firemen's Relief Association Ball which is held every November. With these two operations, he has year-round solicitations. He has 12 to 13 full-time employees.

When his solicitors call for one of the solicitations, they identify the function, give its date, and identifies the organization which sponsors it, such as FOP, Lodge #5. He tells where the money goes only if the person being solicited asks for it. If the person called wants a ticket or wants to consider it, a letter and program are mailed to that person over CHARLES GALLAGHER's

Fraternal Order of Police, Lodge [#]5 – 2 April 2, 1974

(FOP, Lodge #5) signature. People are told that the solicitor works for FOP, Lodge #5 if such a question is asked.

When the letter goes out to the person being solicited, it contains a return envelope and receipt card. The return envelope is addressed to FOP, Lodge #5. When it is received by the Lodge, it is separated from the rest of the mail and turned over to Mr. Slone.

He maintains a 3x5 index card on people solicited. The name, address, telephone number, and business of persons solicited are maintained on this card. The date of the call and any follow-up are noted on the card.

When a payment is received at FOP, Lodge ^{#5} and turned over to Mr. Slone, such payment is posted on the card. Usually a copy of the receipt form is also returned with the payment for the tickets. After posting of the funds, a deposit slip is prepared by Slone's personnel for each day. Deposits are made in a separate bank account in the name of FOP, Lodge ^{#5} and a copy of the deposit slip is turned over to FOP, Lodge ^{#5}. The Lodge then writes the check for Slone for his 55% of the deposits made.

The solicitors get 15% of contributions. If they are steady employees of Slone, they get a 5% bonus, making a total payment of 20%.

Slone arranges for and produces the Show and Dance after the FOP, Lodge #5 establishes a budget and approves the act. FOP, Lodge #5 pays for the expenses related to the Show and Dance.

Mr. Slone pays for postage, telephone, office supplies, equipment, personnel commission and other costs related to his operation.

IRS, a number of years ago, initiated a suit against Mr. Slone and insisted that there was an employee/employer relationship between his company and the solicitors. He settled the case and now pays FICA taxes on all employees, including the solicitors.

About 75% of solicitations for FOP, Lodge [#]5 is repeat business. The 25% new business is solicited from many sources, including the Yellow Pages of the telephone book.

He occupies three small rooms at the FOP, Lodge #5, which space is extremely cluttered and crowded. He reportedly pays \$1,000 a year to FOP, Lodge #5 for rent. He uses no collectors.

Slone reports that he spends about eight months out of each year in Philadelphia. His top commission agent, which is a full long-time employee, made about \$12,000 last year.

Material used by Mr. Slone in connection with his solicitations, as well as other material furnished by him, is attached.

On March 21, 1974, Truman Burke was interviewed at his place of business, the Bank of New Jersey, Operations Center, Moorestown, New Jersey, concerning a number of prior inquiries he had made. At that time he furnished the following information which apparently has never been recorded in the Committee's files.

In late October, probably on a Friday, Mr. Burke asked CHARLES GALLAGHER, President, FOP, Lodge #5, where he could contact DON SLONE, one of the solicitors for FOP, Lodge #5. Gallagher told him that Slone lived in Pittsburgh. The following Monday, Burke visited the Pennsylvania Civil Service Commission where he talked to Sam Begler. Begler said to Mr. Burke, "I understand you are looking for my good friend Slone." Mr.Burke asked Begler which Slone he was talking about. Begler then said it was the Slone that handles FOP, Lodge #5 work in Philadelphia and indicated that if Mr. Burke wanted to know where Slone could be contacted to let him (Begler) know.

On March 25, Mr. CHARLES F. GALLAGHER, President of FOP, Lodge [#]5, was interviewed at the Lodge's offices, 1336 Spring Garden Street, Philadelphia, telephone No. 215:WA3-6960. The Lodge's attorney, ANTHONY D. PIRILLO, JR., was present during the interview.

The Annual Show and Dance is held in May of each year at Convention Hall. Mr. DON SLONE, who has offices at FOP, Lodge #5, does the solicitation for this affair. He solicits for the sale of tickets over the phone. Tickets are then sent to the person requesting them and the money is returned to the Lodge. The price is \$5.00 per ticket for two people. Slone gets 55% of gross solicitations. The Lodge gets 45%, and in addition pays for the cost of producing the Show and Dance.

Mr. ANTHONY KARLVINCE solicits for the FOP, Lodge ^{#5} official ad book. There is no contract in connection with this solicitation, which is a long-time arrangement. Karlvince receives 55% of the gross solicitations. The FOP, Lodge ^{#5} receives 45%, and also pays for printing of the handbook which in 1973 cost \$9,809.

Mr. Gallagher conducted a tour of the Lodge headquarters. The second floor consists entirely of a meeting hall with a small stage and a small kitchen at the rear of the hall. The first floor is made up entirely of offices and related space. The basement is made up of a bar and lounge principally. The Lodge tore down the old property on this site and built the new building about four or five years ago. It is not a particularly elaborate building.

Lodge officers serve for a two-year term. Elections are being conducted the first week of April 1974 for the next two-year term. Mr. Gallagher is running for his second term as President. Installation will be on April 9, 1974. Prior to running for President, he was First Vice President for eight years. The Lodge has 17 officers and trustees, plus the Past President.

FOP, Lodge #5 is a Pennsylvania non-profit corporation and has been granted non-profit charitable status under Section 501 (c) (101) 3.

The Philadelphia Police Home Association is a Pennsylvania non-profit corporation. It files no federal income tax return. Its officers are the same as those for the Lodge.

In addition, there is the FOP, Philadelphia Lodge #5 Death Beneficiary Fund. Transfers are made from the Lodge into this fund generally as needs require. The fund pays for a life insurance policy for all active members who pay full dues, including retirees. Upon death, members are paid a \$1,000 death benefit. Some of the older members do not receive \$1,000 under the terms of the policy because of age or for some other reason, however, the Lodge supplements the payment from the policy so that the member receives a total of \$1,000. This group insurance plan has been in effect since about 1966. The Lodge used to have its own insurance fund and the large surplus in the fund was built up prior to the group insurance plan. Such surplus may be required in the future if a satisfactory insurance plan is not in force.

The Home Association does not pay the Lodge any interest on its loan, which was made for the specific purpose of building the new building. The building is listed among the assets of the Home Association, which Association was created in order to maintain a liquor license on the premises.

FOP, Lodge #5 transfers a portion of the dues to the Home Association, which also receives all of the net income from the official yearbook.

In connection with election expenses, the Lodge is entitled to 220 delegates to the state and national conventions. Two candidates are selected for each delegate post. In order to qualify to run as a delegate and to maintain that status, twelve meetings of the Lodge must be attended during the year. Accordingly, voting machines are rented, ballots are printed, and 30 or 40 members of the Lodge assist in the election process. The election expenses are for these purposes.

The expenses of the House Committee are principally for beer and sandwiches provided to all members attending a Lodge meeting. Three meetings are scheduled each month so that each member can attend one of the meetings regardless of the shift he works for the police department. Fraternal Order of Police, Lodge #5 - 3

The legal aid payments to BASHMAN were for cases of policemen who were injured on duty. Payments to GORSON are mostly for trial board cases of prior years. He no longer is employed by the Lodge. Payments to PIRILLO are for police board of inquiry cases and fees paid for representing members who had been arrested in connection with official employment. Payments to FINEMAN were on the Carter case, which was a criminal case of a number of years back. Fineman is no longer employed by FOP, Lodge #5. The KLAUDER expense is in connection with an FOP, Lodge #5 libel suit against the Philadelphia Inquirer. Payments to PERUTO relate to special cases he handled. He is considered one of the best criminal lawyers in Philadelphia, but is not now employed by the Lodge.

Expenses of the Legislative Committee are principally for the lawyer which handled arbitration with the city in connection with police salaries, working conditions and benefits. In both 1973 and 1974, MARKOWITZ and KIRSCHNER handled the negotiations. In 1971, RICHARD handled the negotiations. Howard

The expense entitled "Ads, Tickets and Donations" is a catch-all account for such things as tickets to various activities, including police dances, donations to the needy, and funeral expenses.

Dues are \$3.00 per month for active working police. A pensioner pays \$2.00 per month. Dues for an associate member are \$12.50 for the first year, which includes \$2.50 for an emblem, and \$10.00 for successive years. Each associate member needs a sponsor. This is a national program which gives no material benefits to the associate member. He does have the opportunity of using the club facilities.

The 1973 state convention expense was for room, board, registration fee and travel to the state convention at Tamiment, Pennsylvania. Registration is held on Sunday and there are four days of convention. 219 delegates were sent to the convention and each received \$170.00, for a total of \$37,230.

In August of 1973, which is fiscal year 1974, 221 delegates were sent by FOP, Lodge #5 to the national convention at Las Vegas. Registration was on Sunday and the convention lasted for four days. Each delegate was paid \$600.00, for a total expense of \$132,600.

The August 1971 national convention was at Phoenix, Arizona. The total cost was \$128,190, which amounts to about \$600.00 per delegate.

> The Lodge is providing an insurance policy for ED McCARTHY, the office manager. It sets aside funds each year for this self insurance policy.

> The Lodge provides a new Cadillac every two years for its newly elected President. The old Cadillac of the prior President is turned in as partial payment for each new Cadillac.

> The Lodge's counsel, ANTHONY D. PIRILLO, JR., has a calling card showing his office as 1420 Walnut Street, 11th Floor, Philadelphia, Pennsylvania, telephone No. 215:546-6500. An inspection of those premises indicates that it is a substantial building. When one steps off the elevator on the 11th floor, it is a very well appointed reception room for the firm of Ettinger, Poserina, Silverman, Dubin, Anapol and Sagot. Mr. Pirillo's name is not listed on the directory board of the first floor or the 11th floor. According to the directory on the first floor and appearances on the 11th floor, this firm occupies the entire floor.

Mr. McCarthy, office manager, made available a copy of the Home Association audit report for the year ended December 31, 1973 and it is attached.
