Office of Special Prosecutor Statewide Investigation for Criminal Justice Corruption

The files of the Governor's Justice Commission and interviews with Commission personnel reveal the following:

74-DF-03-0009

Awarded May 31, 1974 for \$305,000 for the period April 1, 1974 to March 31, 1975.

305,000

The immediate objectives of the Office of Special Prosecutor will be the completion of the Crime Commission investigation into police corruption in Philadelphia. It is anticipated within one month that the Special Prosecutor will be fully staffed. Within one or two months thereafter, the first indictments in cases in which the Crime Commission now has sufficient evidence to indict should be handed down. Prosecution of these cases should continue for approximately one year.

Thereafter, the Office of Special Prosecutor will pursue state- and system-wide corruption through investigation and prosecution, and will become a permanent office upon passage of a bill which has been submitted to the State Legislature.

This grant was endorsed by the Governor's Justice Commission on April 1, 1974 at the same time DS-482-73A was awarded for \$289,445.

This subgrant will be used to assist in the funding of the Office of Special Prosecutor.

Governor's Justice Commission - 2 June 4, 1974

Requests have been received for budget modification on both grants to run only to September 30, 1974. The Attorney General at the Governor's Justice Commission meeting on June 3 talked of this and that – both SPA and LEAA additional funding would be necessary.

Dear Mr. Rinkevich:

This is to request permission to modify the Law Enforcement Assistance Administration grant to the Special Prosecutor's Office by reducing the length of the project from one year to five and one-half months. This grant, in the amount of \$305,000, is for one year commencing April 15, 1974, and was made to the Special Prosecutor's office to assist in its investigation and prosecution of police corruption in the City of Philadelphia.

On May 1, 1974, Attorney General Israel Packel authorized me and my staff to represent the Commonwealth before the Special Investigating Grand Jury empaneled by the Honorable Harry A. Takiff on January 31, 1974. The matters which this grand jury was charged to investigate include corruption on the part of public officials in the awarding of architectural, engineering, construction and milk and dairy contracts with the City of Philadelphia, corruption on the part of public officials in various state agencies including the Liquor Control Board, the State Board of Pharmacy, the State Bureau of Professional and Occupational Affairs and the Department of Revenue for Taxation for Education.

It's difficult for me at this time to provide you with what I anticipate will be my expenses in light of these increased responsibilities. However, I have spoken with Joseph Nardozo who suggested that you, he, John Snavely of the Governor's Justice Commission and myself discuss my budget and the possibility of additional LEAA funds

forthcoming for the Special Prosecutor's office. Mr. Nardozo said that he would be available in two weeks and would come to Philadelphia for such a meeting. By that time, I will have a better idea of exactly how much money I think I will need to set up and operate this office for one year. In light of this office's additional responsibilities, I intend to make a further application for additional funds from LEAA.

For now, I would like to modify the length of the present grant, so that it will run from April 15, 1974, to September 30, 1974.

This letter is to request a modification of the State Discretionary Subgrant (DS-482-73A) awarded to the Special Prosecutor's Office on April 1, 1974.

The purpose of the subgrant was to enable our office to continue the work of the Pennsylvania Crime Commission with respect to investigating and prosecuting allegations of police corruption in the Philadelphia Police Department. On May 1, 1974, Attorney General Israel Packel authorized me and my staff to represent the Commonwealth before the Special Investigating Grand Jury empaneled by the Honorable Harry A. Takiff on January 31, 1974. The matters which this grand jury was charged to investigate include corruption on the part of public officials in the awarding of architectural, engineering, construction and milk and dairy contracts with the City of Philadelphia, corruption on the part of public officials in various state agencies including the Liquor Control Board, the State Board of Pharmacy, the State Bureau of Professional and Occupational Affairs and the Department of Revenue for Taxation for Education. Because of these additional investigations which require my office's immediate attention, I will be submitting shortly a new application to the Governor's Justice Commission for an additional subgrant. At the same time, I will submit a similar application to the Law Enforcement Assistance Administration of the U.S. Department of Justice.

In the meantime, I would request a modification of the outstanding subgrant so as to change its present termination date from April 15, 1975 to September 30, 1974.



In addition to the General Conditions and Conditions Applicable to Fiscal Administration to which this grant is subject, it is also conditioned upon and subject to compliance with the following special condition(s):

- 1. Grantees agrees to insure adherence by subgrantee to (i) such reporting requirements as may be established by LEAA including the requirements for quarterly financial and other progress reports prescribed for discretionary grant projects; (ii) financial administration requirements for discretionary grants as set forth in the LEAA Fiscal Year 1973 Guide for Discretionary Grant. Grant Programs; and (iii) general specifications and, where applicable, any special requirements established by the Guide for Discretionary Grant Programs for the particular discretionary grant program under which this award has been made.
- 2. The Grantee agrees to subgrant these funds to the Commonwealth of Pennsylvania, Department of Justice. For the purposes set forth in the application dated April 8, 1974 and signed by Israel Packel, Attorney General of Pennsylvania which has been adopted by the Grantee as co-applicant pursuant to its application endorsement dated April 1, 1974.
- 3. All published material and written reports submitted under this grant or in conjunction with contracts under the grant must be originally developed material unless otherwise specifically provided in the grant or contract document. When material, not originally developed, is included in the report, it must have the source identified. This identification may be in the body of the report or by footnote. This provision is applicable when the material is in a verbatim or extensive paraphase format.
- 4. Grantee and subgrantee agree if a final court order or any other final legal process requires a change in the goals or objectives of this project, that a request to amend this grant will be submitted to the Law Enforcement Assistance Administration for its approval prior to the further expenditure of any federal funds; and further, if subgrantee is legally prohibited by final court order or other legal process from

pursuing the investigation of police corruption in Philadelphia, that grantee and subgrantee will implement that portion of the project which involves statewide prosecution of criminal justice corruption.

- 5. The subgrantee agrees not to purchase for use in the course of the project any electronic, mechanical or other device for surveillance purposes that is in violation of the provisions of Title III, P.L. 90-351 as amended and applicable state statute, related to wire tapping and surveillance.
- 6. The subgrantee shall within 90 days of receipt of grant award furnish LEAA with information on the methods to insure the physical security of the office and documents pertaining to the project.
- 7. The National Institute of Law Enforcement and Criminal Justice will develop an evaluation plan for this project. Within 30 days of the receipt of that evaluation plan by subgrantee, subgrantee and grantee will inform LEAA of their acceptance of that plan. In the event that the evaluation plan is unacceptable to subgrantee or grantee, negotiations between LEAA and subgrantee and grantee regarding the evaluation plan will commence within 30 days.

11. SUMMARY DESCRIPTION OF PROJECT

This project will pursue the investigation and prosecution, where warranted, of some 200 Philadelphia Police Department Officers named in the March 1974 Pennsylvania Crime Commission Report. LEAA funds will establish the Office of the Special Prosecutor for Pennsylvania with this discretionary grant and a supplementary \$289,445 block grant. The staff will consist of a Special Prosecutor, one/first assistant, four attorneys and ten special investigators. This grant will also support surveillance equipment, a security and alarm system, confidential funds, and office equipment.

It is contemplated that the above investigation and prosecution will take about one year. Thereafter, the Office of Special Prosecutor will pursue state and system wide corruption through investigation and prosecution and will become a permanent office upon passage of a Bill which has been submitted to the state legislature.

This Award of \$305,000 has been made under Title I of the Crime Control Act of 1973, P.L. 93-83 and meets the requirements of the 1974 DF Guideline for Statewide Corruption Control Units (I-4).
