I am in receipt of a letter from Special Counsels Stephen F. Freind and J. Michael Willmann pertaining to your letter concerning the Stagg case.

At the request of the Department of Justice, I have directed that files and other materials relating to the above mentioned action be turned over to Deputy Attorney General Kathleen H. Larkin of the Litigation Division. While the Department of Commerce retains a significant interest in repayment of the loan and prosecution of culpable individuals, the responsibility for decisions bearing on the course to be followed in investigation and litigation rests with the Department of Justice. I have been assured that all efforts will be made to secure such civil or criminal remedies as may be appropriate.

It is my understanding that the question is still before a federal grand jury in New York. In that Ms. Larkin is managing the case, and has cooperated with your staff in filling other requests, it would seem that she is the individual best able to determine what information may be made available at this time.

This is in response to your recent request for information concerning non-bid contracts.

The general practice long followed by the State Council of Civil Defense is to enter into non-bid contracts falling only into two general categories, each described below.

One class of agency contracts includes those covering lease and/or maintenance of standard office equipment, such as postage meters. With only an occasional exception, these are with the manufacturer, or manufacturer's representative, and are at "fixed government rates".

The second class relates to contracts for the supply of lodging and/or meals furnished county and local representatives attending special civil defense training sessions or classes. They constitute authorized sub-contracts under Federal-State "work contracts", whereunder the Federal Government reimburses the agency for the total payments made for the services rendered. (Where training locations permit, the sub-contracts are on an informal quotation basis, with award to the low quoter.)

As examples of the above, the agency's non-bid contracts for the past and current fiscal years are listed below.
