Based on our discussion of yesterday, it is my understanding that my clients are to submit the following documents by July 1, 1974:

- (a) Copies of any Contracts between the Sonder, Levitt & Sagorsky advertising agency (hereinafter the 'Agency') and the Commonwealth.
- (b) Copies of any Contracts between the Agency and any political committee representing either Milton J. Shapp and/or Ernest P. Kline. In the absence of any written contracts, a summary of any oral contracts,

- (c) Copies of cancelled checks indicating personal contributions to political parties, campaigns, or candidates from 1966 to the present. To the extent that my clients do not have cancelled checks going back to 1966, a written summary of their contributions will be supplied for the period during which they have no cancelled checks. This summary, of course, will be subject to their best recollection.
- (d) A copy of the Agency's Articles of Incorporation and any written agreement amongst my clients, or any other writing, detailing the method of compensation followed by the Agency. to the requests set forth in paragraphs (a) - (g) of your several letters of May 31, 1974. If, after receipt of these documents, further documents are needed, such further documents will be promptly provided upon request.
