Dear Representative Gleason:

All the financial records which are included under the subpoena issued. May 14, 1974, to the Custodian of Records for the Allegheny County Republican Executive Committee by the Select Committee on State Contract Practices of the Pennsylvania House of Representatives have been delivered to you this date under separate cover.

I understand that the publicly stated purpose for which you have gathered this information from both political parties in a number of counties in the Commonwealth is that it is in connection with an investigation to determine if there is some systematic pattern of so-called kickbacks to political parties by those businesses and individuals doing business with the state.

It is dismaying to those of us engaged in the practice of politics whenever those few incidents of official corruption do occur. We are perhaps more indignant and put out than other people because those violations frequently tar us all with the same brush when given public attention.

However, I must say that it is equally dismaying to us - and I feel that I am speaking for all or most County Chairmen who received subpoenas, and their predecessors during the last eight years - when a public official uses us and our reputations to achieve some temporary notoriety.

The day after the subpoena was served its issuance received wide publicity in the local mediac complete with the use of my name and that of my Democratic counterpart in this County and with the information that it was in connection with a "kickback probe". No doubt similar publicity prevailed elsewhere in the State.

To many people - especially in these times of general travail in the political arena - even the mere receipt of an investigatory subpoena conveys a degree of suspicion and to some - a presumption of guilt.

You are not so naive to be unaware of this. I can only conclude that you cared nothing for the good names and reputations of many honest and honorable people in both political parties.
