<u>SELECT COMMITTEE APPOINTMENT</u>

Dear:

It is my honor to inform you of my desire to appoint you to be a member of a Pennsylvania House of Representatives Select Committee made up of eleven members.

Pursuant to House Resolution 331, the Select Committee has been tasked with conducting a study of the future use of Soldiers' Grove, specifically the Medal of Honor Memorial known as "The Tides of War." The Select Committee will conduct its meetings and affairs on the grounds of the State Capitol and has authorization to conduct hearings and take testimony. I have enclosed a copy of HR 331 for your review.

HR 331 also requires the Select Committee to report its findings and recommendations for remedial legislation or other appropriate action to the PA House of Representatives on or before November 30, 2012.

The Pennsylvania House of Representatives has passed this resolution to address the issue of space availability while maintaining the purpose of the Medal of Honor Memorial. The original design calls for every two feet to equal a year in time. Under this current measurement within the design, the projected date at which there will be no available space to continue the "Tide" and therefore the recognition of our Medal of Honor recipients is 2016.

It is my sincere hope that you will be part of this very important and honorable endeavor.

If you agree to accept this appointment, please contact my office as soon as is convenient for you and I will inform the Chairman of the Committee, Representative Stephen Barrar.

Stacy Levy and I had a chance to talk and we agree that we could both come together to one meeting of your committee gratis, as part of our commitment to the memorial .

When we first designed the project, we were fully aware that the memorial would need to be a living memorial and would need to accommodate future recipients of the Medal of Honor. We designed a method for adding the heros' names and stories when they received the Medal in the years beyond the completion of the memorial. In fact we have already added an appropriately placed arc for Somalia which honors Randall D. Shughart's act of courage, several years after the project's completion.

We would present to the committee the provisions in our original design proposal that was accepted by the Pennsylvania GSA. This design accounts for the need to continue the arcs and shows the method for how it can be accomplished in such a way that honors the heros and also keeps the memorial system intact. There should be a copy of this original design proposal somewhere in the State Capitol records on the Memorial because we did provide one at the time.
