Hello Ken,

How are things going with you? I want to explain to you the status of the Grant you made possible for the Bainbridge Band.

At present, the Band is spending all it's time in preparing 1991 Summer and Fall Schedules along with practices. takes many hours of work each week since we only rehearse one night a week, which does not leave much time for anything else. For example, some of the major items are rehearsing new music each week to play at concerts, making telephone calls all over Lancaster, York and Harrisburg areas to obtain mucicians to replace the musicians that cannot play the scheduled jobs. (phone bill averages \$30.00 a month). We prepare approximately 150 to 200 programs each week to hand out to the public where concerts are played and prepare newsletters to our Co-Sponsors and Sponsors. (stamps cost approx. \$60.00 each quarterly mailing.) These donations are necessary to buy new music for each concert, (one arrangement costs approx. \$75.00), and to pay musicians for each concert which costs \$18.00 per man. We have utility bills to pay and many other costs. This work is all volunteer by the local musicians which consists of approximately 6 personnel.

When we received the Grant a committee of three men were picked by the Band members. These men consisted of John Degler, the Director, Jack Frank, President and myself, Assistant Business Manager. The check was deposited in the Union National Bank of Mt. Joy, Maytown branch, arrangements made that the three of us have access in writing checks.

Enclosed find a copy of the letter which was originally sent stating the utilization of the monies if we received the Grant.

The money will be utilized in the order listed:

- 1. Percussion instruments
- 2. Lowering the ceiling in the Band hall.
- 3. Uniforms.

Lowering the ceiling is a big item for the Band as it will save heat and also practicing will be much better, it will have better acoustics. Whether we will be able to fulfill all three items we do not know at this time. Efforts are presently taking place to obtain percussion instruments and uniforms which will be added to the present attire. We will receive bids when possible and receive bills for all purchases which will be put on file in the Band Hall.

Enclosed are a few samples of what is prepared before each concert and informing you what is involved in the operation of the Bainbridge Band which consists of approximately 30 to 45 men per concert.

Again the Officers and Members want to thank you for what you have done and it is said that this was the biggest thing ever happened to the Band.

Again, thanks Ken and wishing you good luck in your endeavors.

You are not alone in writing to me with regard to the issue of abortion. Strong public concern continues to be expressed on the matter of whether or not State law should be passed to impose statutory controls on this subject.

Because consideration of law in this area involves the personal and religious views of members and their constituents, those who hold to differing view seem to be unable to find common ground and accomodation of views.

My personal view, in terms of the conduct of my family, is one of firm opposition to the act of abortion.

In my legislative role, I deal with two conflicting forces. Those who wish to impose unbending standards of prohibition against abortion, and those who just as firmly believe that this is the inalienable right of a mother to determine whether or not a child is to be permitted to be born.

I have, in the past, voted against proposals which would attempt to impose State legal restrictions upon abortion, and provide for harsh penalties. I will remain consistant with this view in the future.

My decision in opposing such anti-abortion measures is separate and apart from my personal convictions. It is based upon my belief that such laws could not be enforced and would be unworkable. Just as the prohibition of alcohol failed to halt consumption and gave rise to widespread acts of illegality and citizen disregard of law, I feel the same thing would happen if the State ever attempts to police abortion.
