

MILTON SHAPP

Milton Shapp has told reporters that his Administration is clean and honest.

The latest Shapp article is entitled: "Doing business with the mob" and it tells a complex story of how organized crime is making a lot of the top level decisions in the Shapp Administration:

— Shapp himself admits getting \$20,000 unreported cash in unmarked envelopes (he says he doesn't know what he did with it), and most recently has admitted the campaign assistance of fugitive from the FBI, Robert Vesco;

— The Shapp Administration has been riddled with kickbacks, extortion, bribery and all sorts of corruption in the Liquor Control Board, the Insurance Department, and State Police, his State Legislature, the Department of Transportation, the Turnpike Commission; State leases; the Revenue Department; the Department of State. You name it . . . Shapp people have done it.

Only a few are getting caught. Now . . . this November 2nd . . . we can do something about the corruption in our State Government by electing Patricia Crawford as State Treasurer and Patrick Gleason as State Auditor General.
