HOUSE BILL 142, P.N. 3187; Final passage 6/3/74 (100-76). Amendment provides that:
 1. No public utility rate increase shall be retroactive; 2. The PUC shall conduct hearings on rate changes except those filed by a common carrier by motor vehicle; 3. The PUC shall not fix temporary rate increases.

PROS

1. Prevents accumulation of higher billings and subsequent lump-sum billings which may arise during a drawn-out PUC decision.
2. Requires the PUC to examine new rates for lawfulness and justification.

CONS

1. Rate decisions can be delayed as long as 14 months.
2. Market conditions can change even between filing and approval and utilities may not be able to absorb interim cost increases.

PRO

1. Presently new tenants **cannot** get the water service resumed until they pay the bill of the previous tenant.

CON

1. Presently, it is possible for the utility to attach a lien to the landlord's real estate and hold a sheriff's sale to obtain back payments.

HOUSE BILL 172, P.N. 1037; Final passage 5/1/73 (176-3). Amendment requires fire or casualty insurers to include an updated list of bases for cancellation on all policies in eight-point type (same size as the text of a House Journal).

PROS

1. Increases public's awareness.
2. Requires complete disclosure of underwriting policies before the fact.

CONS

1. Increased printing costs.
2. Standardized forms could not be used in Pennsylvania.

CONS

1. This provision is already a commonly included element of fire policies.
