1. House Bill 372	Ross		HB 372 amends the First Class Township Code to allow for electronic auction of township personal property. This legislation would take effect immediately.
2. House Bill 373	Ross		HB 373 amends the Borough Code to allow for electronic auction of borough personal property. This legislation would take effect immediately.
3. House Bill 374	Millard		HB 374 amends Act 34 of 1953 relating to contracts of incorporated towns to allow for electronic auction of incorporated town personal property. This legislation would take effect immediately.
4. House Bill 377	Everett		HB 377 amends the Pennsylvania Construction Code Act (Act 45 of 1999) known as the Uniform Construction Code (UCC). This legislation would take effect immediately.
5. House Bill 562	Gillen		HB 562 amends the Agricultural Area Security Law by providing a statutory definition for "contiguous acreage." The effective date is immediately after enactment.
6. House Bill 915	Adolph		HB 915 amends the General Appropriations Act of 2010 by reducing state basic education funding by \$387,816,000 and replacing it with an equal amount of federal education jobs fund money which must be appropriated for fiscal year 2010-2011.
