1. House Bill 197	Gingrich		HB 197 amends Title 53 (Municipalities Generally), in area government and intergovernmental cooperation, further providing for review of agreement by Local Government Commission.
2. House Bill 960	Gingrich		HB 960 amends the Public Welfare Code providing for a Fraud Detection System and for an Income Eligibility Verification System (IEVS) with the Department of Public Welfare in order to verify eligibility, eliminate duplication of assistance and deter fraudulent activity. Effective date is immediately.
3. House Bill 1251	Toohil		HB 1251 amends the Public Welfare Code by realigning the definitions and penalties for welfare fraud with those in the Crimes Code. Effective date is in 60 days.
4. House Bill 1261	Quigley		HB 1261 amends the Public Welfare Code requiring the department, when awarding cash assistance, to determine eligibility and the payment amount based on an applicant or recipient's county of residence. Effective date is in 60 days.
