1. House Bill 197	Gingrich		HB 197 amends Title 53 (Municipalities Generally) to further provide for review of agreements by the Local Government Commission. This legislation would take effect in 60 days.
2. House Bill 292	Keller		HB 292 amends Title 53, Section 5511 to increase the written or telephonic price quotation base amount maximum for parking authorities and to provide for the annual indexing and adjusting of these figures for inflation. This legislation would take effect immediately.
3. House Bill 396	O'Neill		HB 396 amends both the Crimes Code and the Judicial Code concerning drug delivery resulting in death.
4. House Bill 639	Taylor		HB 639 removes a date that impedes an increase in the fees that help pay for affordable housing programs in the city of Philadelphia. This legislation takes effect in 60 days.
5. House Bill 804	Masser		HB 804 amends the Judicial Code concerning exemptions from jury duty.
6. House Bill 1297	Everett		HB 1297 amends the Public Welfare Code adding a new section requiring random drug testing for applicants and recipients with a felony conviction for a drug offense. Effective date is in 60 days.
7. House Bill 1312	Stephens		HB 1312 amends the Public Welfare Code reforming the special allowance program from a grant program to a Job Transition loan program. Effective date is in 60 days.
