The effective date is 60 days after enactment.
2. House Bill 584	Daley		House Bill 584 designates the Claysville Interchange of Interstate 70 in Washington County as the Sergeant Nathan P. Kennedy Memorial Interchange. This legislation would take effect in 60 days.
3. House Bill 585	Daley		House Bill 585 designates the bridge in Carroll Township, Washington County, on State Route 2023 over Pigeon Creek as the Stanley Jurgaitis Memorial Bridge. This legislation would take effect in 60 days.
4. House Bill 586	Daley		House Bill 586 designates the Donora-Monessen Bridge in Washington and Westmoreland Counties as the Stan Musial Bridge. This legislation would take effect in 60 days.
5. House Bill 860	Kula		House Bill 860 amends Title 34 (Game and Wildlife Code) to lower the permissible blood alcohol content for adults while hunting/furtaking. This bill also reduces the window of time allowable to collect a sample of breath, blood or urine for testing, and allows the Game Commission to promulgate regulations regarding consent and administration of testing.
6. House Bill 869	Marsico		House Bill 869 authorizes funeral directors to display flashing or revolving purple lights on any funeral processional vehicle which is being driven in a funeral procession. This legislation would take effect in 60 days.
7. House Bill 1022	Wheatley		House Bill 1022 amends the Judicial Code concerning the acquisition of title to property through adverse possession.
