1. House Bill 170	Miller		House Bill 170 requires motor vehicles to observe a minimum 4 foot safe passing distance, at a reduced speed when possible, whenever overtaking bicycles on the roadway. The legislation also includes other provisions to enhance cycling safety on roadways. This legislation would take effect in 60 days.
2. House Bill 257	Grove		House Bill 257 amends the Public School Code concerning school construction projects.
3. House Bill 285	M. Keller		House Bill 285 amends the Public School Code relating to bid limitations for construction and supply contracts.
4. House Bill 1055	Mustio		House Bill 1055 creates a freestanding act to regulate the professional employer organization (PEO) industry. This legislation would take effect in 180 days.
5. House Bill 1278	Brennan		House Bill 1278 amends the act of April 12, 1951 (P.L. 90, No. 21), known as the Liquor Code, as reenacted and amended, to further provide for sales by liquor licensees and restrictions for special occasion permits. The effective date is immediately after enactment.
6. House Bill 1345	Taylor		House Bill 1345 amends the Public School Code concerning the Safe Schools Advocate in School Districts of the First Class.
