1. House Bill 735	Gillespie		House Bill 735 amends Title 34 (Game and Wildlife Code) by removing the requirement that hunting licenses be displayed and by removing the corresponding penalty. It also requires that hunters or trappers provide proof of licensure to any landowner whose land that person may be occupying or to any officer whose duty it is to enforce Title 34.
2. House Bill 870	Everett		House Bill 870 adds recreational noncommercial aircraft and ultralight operations on private airstrips as uses covered under the Recreational Use of Land and Water Act. This legislation would take effect in 60 days.
3. House Bill 1458	Tallman		House Bill 1458 amends the Vehicle Code to provide a higher fine for a violation of nonreciprocity of operational limitations.  This legislation would take effect in 60 days.
