1. House Bill 338	Killion		House Bill 338 amends Chapter 63 (the Child Protective Services Law) of Title 23 (Domestic Relations) providing for penalties for false reporting of suspected child abuse and for expedited hearings. Effective date is in 60 days.
2. House Bill 720	V. Brown		House Bill 720 amends the Pawnbrokers License Act concerning pledger identity and hold orders.
3. House Bill 797	Farry		House Bill 797 amends Sections 108 and 301 of the Workers' Compensation Act (Act 338 of 1915) designating cancer as an occupational disease for firefighters who have served for at least four continuous years in firefighting. This legislation would take effect immediately.
4. House Bill 1054	Mustio		House Bill 1054 allows retired professional engineers, land surveyors and geologists to obtain a retired-status license, and thereby continue to identify themselves by the title PE, PLS or PG, Retired. This legislation would take effect in 60 days.
5. House Bill 1264	Parker		House Bill 1264 adds a new section to the Judicial Code concerning expert testimony in certain criminal proceedings.
6. House Bill 1618	Gillespie		House Bill 1618 amend the Crimes Code concerning Assault of a Law Enforcement Officer






