House Bill 1232	Geist		House Bill 1232 establishes a penalty for communities that adopt local ordinances that may conflict with provisions of the Vehicle Code and extends the Philadelphia Automated Red Light Enforcement (ARLE) camera pilot program until December 31, 2016. This legislation would take effect in 60 days with the exception that the changes to Section 9010 regarding County Liquid Fuels Tax funds takes effect January 1, 2012.
