1. House Bill 1329	Keller, F.		House Bill 1329 raises the threshold for the Prevailing Wage Act from \$25,000 to \$185,000 and creates an annual inflation adjustment to the threshold. This legislation would take effect in 60 days and apply to new contracts only.
2. House Bill 2021	Emrick		House Bill 2021 designates a portion of PA Route 191 in Washington Township, Northampton County, as the World War II Homefront Heroes Highway. This legislation would take effect in 60 days.
3. House Bill 2059	Miller		House Bill 2059 amends the Agricultural Area Security Law to provide for inspections of preserved farmland and nullifying certain provisions in regulation. This legislation would take effect immediately upon enactment.
4. House Bill 2060	Tallman		House Bill 2060 designates the bridge carrying State Route 94 over Bermudian Creek in Latimore Township, Adams County, as the Sgt. Michael C. Weigand Memorial Bridge. This legislation would take effect in 60 days.
5. House Bill 2106	Ross		House Bill 2106 amends the Agricultural Area Security Law to provide for restrictions and limitations on preserved farmland. This legislation would take effect in 60 days upon enactment.
6. House Bill 2133	Oberlander		House Bill 2133 designates the bridge carrying State Route 66/28 over Redbank Creek between Armstrong County and Clarion County as the Sergeant Joseph M. Garrison Memorial Bridge. This legislation would take effect in 60 days.
7. House Bill 2134	Micozzie		House Bill 2134 amends Pennsylvania's Risk-Based Capital statutes concerning company level action events. It would take effect in 60 days.
