1. House Bill 528	Boback		House Bill 528 creates the Long-Term Care Consumer Relocation Coordination Act providing practices regarding certain facilities, licensing agencies and Area Agencies on Aging when coordinating and relocating consumers from those facilities. Effective date is in 180 days.
2. House Bill 910	Grove		House Bill 910 designates the Pennsylvania Long Rifle as the official firearm of the Commonwealth of Pennsylvania and designates the Piper J-3 Cub as the official State aircraft of the Commonwealth of Pennsylvania. This legislation would take effect immediately.
3. House Bill 2275	Grell		House Bill 2275 amends Title 42, Judicial Code, and Title 57, Notaries Public, by updating these laws concerning declarations and notaries public. The effective dates vary by provision.
4. House Bill 2349	Smith, S.		House Bill 2349 re-designates the bridge on State Route 322 over North Fork Creek as the Purple Heart Memorial Bridge of Jefferson County. This legislation would take effect in 60 days.
5. House Bill 2400	Marsico		House Bill 2400 amends the Crimes Code concerning wiretaps. It would take effect in 60 days.
6. House Bill 2406	Helm		House Bill 2406 authorizes and directs the Department of General Services (DGS) to convey a .029 acre parcel of land at the intersection of Elmerton Avenue and Kohn Road in Dauphin County to the Pennsylvania State Employee Credit Union (PSECU). This legislation would take effect immediately.
7. House Bill 2407	Hackett		House Bill 2407 amends the Older Adult Protective Services Act allowing the Department of Aging to prescribe the manner that fingerprints are submitted for background checks. Effective date is immediate.
