1. House Bill 1659	Pyle		House Bill 1659 provides for the review of permit applications by the Department of Environmental Protection. The act shall take effect in 120 days upon enactment.
2. House Bill 1718	Creighton		House Bill 1718 amends the Pennsylvania Municipalities Planning Code (MPC) regarding the time period to dispute the amount of review fees for projects, the amount of financial security held at the end of a project and arbitration over disputed fees. This legislation would take effect in 60 days.
3. House Bill 1719	Creighton		House Bill 1719 amends the Municipality Authorities Act (MAA) within Title 53 (Municipalities Generally) regarding the amount of financial security held at the end of a project, the time period to dispute the amount of review fees for projects and arbitration over disputed fees. This legislation would take effect in 60 days.
4. House Bill 2159	Grell		House Bill 2159 amends Title 13 (Commercial Code) in order to update the provisions in the Commercial Code relating to secured transactions. This legislation would take effect on July 1, 2013.
5. House Bill 2467	Micozzie		House Bill 2467 eliminates the requirement that salvage title documents be notarized for vehicle owners that transfer a vehicle title to an insurer. This legislation would take effect in 60 days.
