The Beaver Valley Council of Governments (COG) respectfully requests a meeting with you regarding the proposed location of an infectious waste incinerator in Harmony Township, Beaver County. We would like to limit the number of people attending this meeting to facilitate an open exchange of ideas.

We have researched this subject in depth and are aware of the problems of waste disposal facing the health industry and regulatory agencies at this time. However, we have some concerns regarding the proposed location of this infectious waste incinerator that we wish to address directly with you. Our concerns are summarized below.

What concerns do we have regarding the proposed location of an infectious waste incinerator facility in Harmony Township?

We are concerned that some "hidden" costs or externalities associated with the operation of this facility will be unfairly placed on residents of our communities. These economic costs include:

- 1. Potentially adverse effects of the proposed incinerator location on:
  - a. our ability to attract other businesses into the Aliquippa Ambridge-Harmony Enterprise Zone, and;
  - b. residential and industrial property values for areas adjacent to the proposed location.
- Increased air pollution and the long term health effects and medical costs of exposure to pollutants emitted by such a facility to residents, especially children, living nearby.

- Increased public service costs, e.g. police and fire protection, and additional costs to train and equip personnel to handle emergencies involving infectious, hazardous wastes.
- 4. Additional Road repair/maintenance costs.
- Increased risks of exposure of residents to infectious wastes by routing infectious, hazardous wastes through heavily populated areas or over long distances.

What criteria do we recommend be considered in deciding on the need for and the location of a new infectious waste incinerator facility?

Some of the criteria we believe are relevant to decisions on the need for and location of a new infectious waste incinerator facility are:

- 1. Geographical area that the proposed facility is intended to serve.
- Estimates of the current and projected volumes of infectious wastes generated within this area.
- Estimates of current waste incineration capacity and future incineration capacity needed to handle the volume of infectious waste that is expected.
- 4. Cost/benefit analysis of the proposed facility. This analysis should include estimates of "hidden" economic costs or externalities to residents or communities in the affected area.
- 5. Environmental Impact Study.
- Strict enforcement of existing emission controls and standards, as well as regular monitoring of bacterial/viral emissions and operating efficiency.
- Adjustment of the siting requirement according to the size of the incinerator.

What solutions do we suggest to minimize the problem of infectious waste disposal?

We offer the following suggestions for discussion to minimize the volume and/or costs of disposing of infectious wastes:

- Require the segregation of infectious/hazardous and non-infectious wastes, where feasible, to permit re-cycling and reduce the volume of infectious waste that needs to be incinerated.
- 2. Promote on-site incineration or incineration at smaller regional facilities to minimize the transportation of these wastes and to place the costs of disposing of these wastes more directly on the communities or facilities that generate them.

In closing, we would greatly appreciate meeting with you during your next trip to Pittsburgh to discuss these issues more fully.

The Department Safety Improvement and Congestion Reduction Program (ECONS) provides funds to construct projects with demonstrated benefits as documented by properly prepared engineering study reports. These engineering studies are submitted through the planning process of the local metropolitan planning organization (MPO). The District Traffic Engineer can address the specific requirements for this process.

In the case of traffic signal improvement projects for existing signal locations, the enhancement expected will be above the normal service provided by fully maintained signals operating in accordance with the Traffic Signal Permit.

ECONS candidate projects are ranked and compete for program funding according to their benefit-to-cost (B/C) ratings on a statewide basis. Projects with lower B/C values can be enhanced through local contributions. In this way the benefit-to-cost (State cost) will be increased.

I appreciate your concern for the improvement of the existing traffic signals in Ambridge. If I can be of any further assistance, please do not hesitate to contact me.

Peoples Gas has been notifying customers of two changes which affect how the accounts of certain landlords and tenants will be handled. Since there is some confusion about the changes and some customers may contact your offices, the following information is provided for your use:

• Landlord/Tenant Act: Beginning early this year Peoples began to formally notify customers of the new requirements of the Landlord/Tenant Act (Act 54, 1993) which became effective in September 1993. This Act requires landlords to be responsible for all utility costs of residential buildings or mobile home parks which contain one or more dwelling units which are not individually metered. The Act does not change customer rates.

• <u>Customer Class Change</u>: As a part of the recently completed Peoples Base Rate Case which was approved by the Public Utility Commission on July 21, the customer class where one meter serves more than one house, mobile home, or apartment will be changed from "Residential" to "Commercial". The "Commercial" class also applies to dwellings where one meter is connected to an appliance or appliances (typically furnaces and/or hot water heaters) serving more than one apartment.

All customers identified in our billing system as meeting the specified criteria were notified of the change with a letter on July 21, 1994. They were asked to verify our records in order that we could classify and bill them properly. Customers whose class will change to commercial as a result of this rate filing may experience an annual increase depending upon their individual circumstances. This change only affects a small number of our total customer base.

Any landlords who previously were not paying sales tax on rental property will now be billed for sales tax in compliance with the State Tax Code.

While many customers will experience both changes, they are not related in any way. The changes to the Landlord/Tenant Act were enacted by the Legislature in 1993 and apply to all landlords in the state. The Customer Class Change is the result of a Peoples Base Rate Case approved by the Public Utility Commission and applies only to Peoples' customers. The class change does, however, allow Peoples customers' classification to be consistent with other utilities in the state.

Dear Susan:

In the midst of my battle with PENDOT, I sometimes overlook the fact that in addition to you being my State Representative, you also are an elected official of the Commonwealth, and as such, do have obligations to the Commonwealth. With regard to the upcoming meeting with Messers Yerusalim and Moyer, I look upon you as an interested, but impartial third party. Nevertheless, there will be one point in my overall presentation at which I want you to be strongly behind me.

The matter started with a letter I wrote to PENDOT dated July 24, 1992, which was ignored. Follow-ups were likewise ignored. Deputy Secretary William Moyer's letter of October 5, 1993 escalated the matter from one of nagging, but minor status, to one of maximum importance. I don't think I sent you this letter, but it did contain the potential to put SHAUGHNESSY ASSOCIATES totally out of business. I did respond to that letter on October 20, 1993 (you did receive a copy), and did meet with Messers Moyer and Fred Bowser on November 4, 1993. Simultaneously, I took vigorous actions designed to minimize the damages that were sure to follow the PENDOT proposed action. I intend to treat this history strictly as a factual matter, except for my October 20th letter to Mr. Möyer.

At the present time, there are three (3) PENDOT related Price publications on the market. The "high end" publication, THE COMPLETE UNOFFICIAL PENDOT BULLETIN 50 has been published annually by us since 1992, and next years edition is well under way. The "low end" publication, THE CONDENSED UNOFFICIAL PENDOT BULLETIN 50, again published by us, is new this year, and is prepared to guidelines or "specifications" given to us by Mr. Moyer. The "low end" publication, The Construction Cost Catalogue For Standard Construction Items -Bulletin 50, is published by PENDOT, and this year's edition is available to the public for the first time since 1980 or 1981.

The "high end" publication stands alone. There is no competition with it today, and we do not foresee any competition in the reasonable future. The "low end" publications, despite some significant differences in both price and

content, are in direct competition with each other. There is no question but that one of these "low end" publications has to go: There is a question as to which one should "disappear".

I'm more than willing to give up our "low end" publication, but only if I can get something for it. Knowing Howard Yerusalim and Bill Moyer as well as I do, this will be difficult. For starters, Howard, who I sincerely believe is almost totally ignorant in this whole matter, even today, is well known for his reluctance to admit a mistake. Bill Moyer possesses an extremely high ego, and likewise is of the firm belief that government can do everything better than private industry.

The obvious approach is to "snooker" these two individuals into accepting a position that they may not like, but one that they cannot find a way to avoid. You alluded to this approach on the phone last Friday, but didn't come right out and say it. Fortunately, the documentation is ideal for a "snookering" operation.

There were a number of statements made last fall by Howard at the Annual APC/PENDOT Meeting, some in private, and a particularly potent one before some 600 people. Likewise, there were some things that happened between Bill Moyer and me, and I've got enough private documentation to defend my veracity. To this we can add the letter I received from the Governor's office. While Special Assistant Darby may have conducted his investigation from the wrong direction, he nonetheless made two statements that PENDOT cannot weasel out of.

In the 2nd paragraph, Mr. Darby said:

... "This document provides a reference for both the contractor and department staff for determining appropriate prices for extra work on construction contracts, thereby reducing the time and effort in negotiating prices for this additional work. For this reason, it is a practice that this office would support."

If Yerusalim and Moyer agree with the foregoing statements, and how can they disagree, they will be well on the way to being "snookered". Of the three (3) publications available, only one (1) - our "high end" publication - meets the foregoing. The "low end" publications, be it our's or their's, will not do the job. I intend to ask Yerusalim and Moyer to literally show us just how their publication, or our's, will meet the above statement. This is where I would like your strong support. My request will be entirely reasonable under the circumstances. As I write this now, the thought is going through my head

that neither Yerusalim or Moyer has the requisite competence. I'll get around that by bringing it up out of sequence — at the beginning of the meeting — and suggesting that they get on the telephone and call in someone with the requisite competence. Their building does start to clear out with a vengeance at 4:00. As far as you knowing just what is going on, don't worry. I'll translate into lay person's language, and the PENDOT contingent certainly knows enough to question me if I translate incorrectly.

For this test, I have in mind two specific happenings on recent jobs, and Susan, they can't win.

At this point, and assuming that all necessary "stroking" has taken place, we can get into the three possible solutions. The first is that they can quit publication, which is not what I want. Second, they can agree to my plan, which is what I want. Or third, PENDOT can elect to do nothing. If they choose the latter, I refer the entire matter back to Mr. Darby in the Governor's Office with documentation he cannot refute, or ignore. I don't think PENDOT gave him the whole story.

Exhibit 1 attached shows the present publishing configuration, and also the documents which I currently use in developing and editing our publications. The documents listed all originate with PENDOT, and I obtain them from a variety of primary and secondary sources.

Exhibit 2 attached shows the proposed configuration. Under it, we will discontinue our "low end" publication. In return, we want PENDOT itself to be the primary source of our documents, and further, we want the documents in electronic form.

In a nutshell, Susan, I don't have any problem with giving up the "low end" publication. The market potential, in terms of numbers, is great, but the actual sales and profits are minimal. But, if I do give this publication, I want something in return, and the only thing that PENDOT has that I want is source documents and specifically in electronic form. The stumbling block to PENDOT data in electronic form is Howard Yerusalim. He's afraid of contaminating the Department's computers.

With the exception of the electronic format, the foregoing is the proposal I had in mind when I asked you to set up a meeting with Howard. Since that time, and as a natural progression in the direction my business is going, I have started to set up a Computer Bulletin Board. This BBS, which will be on line by October 1, 1994 at the latest (possibly on line by the 26th) will be a

Subscription BBS dedicated to Highways in general, and PENDOT in particular. Subscription fees will be waived for the following: State Representatives; State Senators; and Selected members of the Media. PENDOT, and strictly because of its size, will be charged reduced fees.

The BBS is going on line, with or without the availability of electronic documents from PENDOT. Our sources of documents today are locked, and we have additional sources lined up. If we have to keypunch, it is not a big problem, as the feasibility is there regardless. But, the electronic format would help.

We do, though, have competition in this effort from others. Pennsylvania One Call is seriously investigating the pros and cons of running their own BBS. At best, though, they probably won't be on line until early next year. APC, with which you are familiar, has been talking BBS with PENDOT for the past 1 1/2 years. APC definitely needs PENDOT documents in electronic form in order to get on line (they don't have the resources to keypunch), and in any event, I don't think they can make it until possibly mid-November. PENDOT may have made a firm commitment to APC. If we find that this is so, it would definitely be in order for you to ask Howard why he can't make the same commitment to me.

I'm pushing for October 1st for competitive reasons. Our Subscription Fee will be about half of that contemplated by APC, and further, it will be better for me if APC joins my effort. With the exception of this years Unit Prices, the other elements of information which APC contemplates are already in my computer, including some additional goodies, such as the 12 Year Plan.

. This letter is long enough. If I don't talk to you before hand, I'll see you in Howard's office on the 26th.

Susan, thanks again for all you've done.

The data your office provided relates to the Ohio Edison-Niles Station.

pH - 8.1 Total Volatile Solids 6.5

Note: pH range adequate to prevent leaching. Total Volatile Solids 6.5 x 10,000 which would equate high numbers, but acceptable for landfilling.

If you have any questions after your review of my tables against the Applicant Submitted Data, please feel free to contact my office (717-629-4430).

Mre. Laughlin, I know that your constituents are probably really upset with the possibility of the waste being received at Ambridge, but from my review of the data presented and from a phone inquiry, the landfill is a secure landfill and it seems a positive action that the material be accepted and processed in the proper manner and not land-applied somewhere.

In furtherance of your Inquiry, if there were some questions you feel that you might want answered:

- a. What is the pH of the soil that will be utilized for Cover Media?
- b. How is water going to be kept out of the individual cells during operation?

1

- c. Define if there are any new liner requirements?
- d. How will the pH of the soil be checked to keep it from going acidic and loosing alkalinity?
- e. How will old leachate from the old landfill operation be kept from affecting the new process/operation and intended disposal materials?

Mrs. Laughlin, we both know that this isn't Whipped Cream that we are dealing with, but it also is not the worst possible. I suggest, if I may, that you sit the intended operators down and request a Host Fee per Ton and also a suggested up-front donation to a Municipal Project (Youth Center, Playground, etc.). This will go a long way to help people feel a little better about the whole situation.

In closing, if the Applicants are not responsive to these suggestions there are a few more questions that we can fire back at them. I hope that I have helped. Please advise.

Governor Tom Ridge has asked me to respond to your recent letters regarding the reopening of the Ambridge Landfill in Beaver County for acceptance of fly ash from Ohio Edison's Niles, Ohio power plant. The technical staff of the Department of Environmental Protection's (DEP) Southwest Regional Office has informed me that Gabe Sacco, the permittee, has a valid residual waste permit for the Ambridge Landfill and has met the requirements of the very stringent residual waste regulations to allow reopening of this site. This permit modification was issued on July 22, 1996.

We appreciate the concerns of the citizens located near this facility, and will continue to ensure their safety and well-being through active compliance monitoring. Our Air Quality and Waste Management inspectors in the Southwest Region will be inspecting this facility on a regular basis. They will ensure that the operators of this facility meet the environmental standards necessary for the safety of our citizens.

Dear Governor Ridge:

After a meeting and a hearing with the Department of Environmental Protection concerning the re-permitting of a landfill in Harmony Township, Beaver County, residents of the communities surrounding that landfill still are strongly opposed to its reopening.

I am writing to you once again on their behalf in the hope that you will intervene in any way possible. The residents of Ambridge Borough and Harmony Township are convinced that the reopening of the Ambridge Landfill will seriously jeopardize the health and safety, as well as the economic security, of their communities.

As of now, no final decision has been made on the reopening of this landfill, which has been closed since 1988. However, after a meeting and a public hearing before the state Department of Environmental Protection was held to entertain a substantial list of residents' concerns, all indications are that the reactivation of this landfill's permit will take place.

The residents do not understand this seeming betrayal by their state, and are understandably upset.

The residents' concerns are warranted.

For at least one year, the landfill, which will be accepting flyash from both in-state and out-of-state sources, will be operating under old DER regulations, meaning less stringent standards will be in effect. The operators of the landfill have assured us no contamination of the surrounding area took place before, nor will any take place this time, but residents have presented evidence to the contrary.

The short-term and long-term health effects due to exposure to flyash dust are largely unknown, and children who grew up near the flyash dump when it was previously in operation have experienced respiratory and other problems that can only be traced back to the landfill. In addition, thinking the landfill had closed for good in 1988, the residents of Harmony Township planned construction of a



children's playground adjacent to the site. They are greatly concerned not only for the health of their children in light of the constant dust that will be present, but for their safety, too, considering the constant truck traffic that will be present in the area.

Finally, none of this speaks to the serious economic damage that will be done to these communities, where property values will surely crash with the reopening of this dangerous, noisy and dirty landfill.

In short, Governor Ridge, the residents of my district do not understand why, when the DEP has admitted there are plenty of other places in Pennsylvania where this flyash could be disposed of, their communities once again have to put up with a problem they thought they were rid of. To the residents of these communities, it looks as if the DEP, who they understand is supposed to protect and defend the public's health, safety and environment, has instead decided to sacrifice those concerns in the name of private profits for someone else.

These residents have made clear to me their feeling that for all its talk about ending Pennsylvania's reign as the "dump capital of the country," little has been done by your agency to stem the tide of outof-state trash flowing into this state. That DEP is seriously considering reactivating the permit for the Ambridge Landfill--whose stated purpose is to accept flyash from Ohio--is testament to that.

A previous letter I wrote to you and to Secretary Seif-- as well as the other letters you have received from concerned citizens --brought little or no response. I am writing to you once again on their behalf and mine asking you to please intervene in this situation in any way possible. Harmony Township already has had to hire its own environmental lawyer to look out for the interests that DEP is supposed to be representing--at a cost to the township of hundreds of thousands of dollars.

Governor Ridge, we cannot continue to sacrifice the health and property of Commonwealth citizens to the god of corporate profits-especially when those corporations are located outside Pennsylvania. Ohio Edison must not be allowed to use this site for the disposal of flyash. The residents who will have to live with the consequences of whatever decision DEP makes in this case urge you to do anything you can to ensure that their communities will remain healthy, safe and vibrant far into the future.

Thank you for your attention to this matter.

Dear Rep. Laughlin,

On February 13, 1996, by a vote of 48-0, the Senate passed SB 1352. If this bill remains HB 1352, I am hoping you will take the time to read and understand the contents of this bill. Since you have had your reservations in the passed about Outcome Based Education, if this bill passes the House, it will make OBE law in Pennsylvania.

Senator Rhoades claims that SB 1352 would "doom OBE", according to an AP article dated February 3, 1996. This is not true considering SB 1352 does not repeal the 53 Student Learning Outcomes. This bill eliminates the teacher's academic freedom to set the standard in their classroom. Governor Ridge's 12 member commission will set the standard. The commission will create the standards for the **existing** student learning outcomes. Understand that the **standards** are the **degree** to which each student must meet the student learning outcomes in order to graduate. Governor Ridge's commission will control the graduation requirement, not the local district. There is **no** local control here. SB 1352 does nothing to eliminate Chapter 5 **regulations**.

SB 1352 does not stop the Strategic Planning Process. In section 7 of the bill it states, "...The Secretary of Education is hereby authorized to develop a New Strategic Planning cycle...".

Realize that the state board has *never* had the authority to change the graduation requirements, only the General Assembly has that authority.

### School District Reorganization Act of 1963 Act 299

"develop or cause to be developed an evaluation procedure designed to measure objectively the adequacy and efficiency of the <u>educational program</u> offered by the public schools of the Commonwealth, the <u>evaluation procedure</u> shall be so constructed and developed as to provide each school district with <u>relative</u> <u>comparative data to enable school directors and administrators to more readily appraise the educational</u> performance and to effectuate without delay the strengthening of the district's educational program. Tests developed...shall be used for the purpose of providing a <u>uniform evaluation</u> of each school district..." Does this authorization give the state board authority to mandate and monitor individual attainment of the student learning outcomes as a graduation requirement?

### STATUTORY AUTHORITY OF GRADUATION REQUIREMENTS:

Public School Code of 1949, (24 P.S. 1-101-27-2702) and sections 1317-1320 of the Administrative Code of 1929, (71 P.S. 367-370).

(a) Each board of school directors shall identify planned courses for which credit toward graduation shall be awarded.

The state needs SB 1352 to make legal what they have already done. With this bill, our children will no longer graduate with a diploma from a specific school district. It will be a Pennsylvania diploma, Certificate of Initial Mastery or a Career and Academic Passport.

Look what is happening in Ambridge School District. There are forty nine teachers in the high school that have signed a petition objecting to outcome based education. They are suppose to be the "professionals" and know what is best for their students. Where is their local control? This is not just in Ambridge, but all over Pennsylvania. Now that teachers are having to implement their Strategic Plan, it looked better on paper.

I would like to sit down and talk to you when you return to your local office. I am interested in what your position is on HB 1352 (if it has with the same number). There is a lot more to this bill and I hope to have the chance to discuss it with you. Thank you very much for your time. Please let me know when it will be convenient to get together to discuss this bill.



For more than eight years, the state of Pennsylvania has not increased its share of the personal home care supplements that assist residents who receive Suplemental Security Income or SSI. The Ridge administration, in its recently released 2001-2002 budget has proposed a subsidy increase that would amount to about \$2 per day.. While we are grateful for that consideration, the first in eight years, we believe that higher levels of subsidies are necessary to continue to provide adequate care to some of our most needy residents.. We would like to invite you to join us at a breakfast meeting on Thursday, March 29<sup>th</sup>, 2001, at Lindy's restaurant (Brodhead Road, Center Twp., from 8:00 a.m.-9:30 a.m. to discuss this matter further with most of the personal care operators in Beaver County. We are inviting all of the Beaver County State Legislators to this meeting.. We have at least one personal care home operator in every legislative district in the county.

The 24 Personal-care home operators in Beaver County provide quality living care to more than 1250 residents at any one time. Many lower income level residents rely on the Pennsylvania State supplied, personal –care home supplement to their Supplemental Security Income (SSI) for their personal expenses. While the Federal government adjusts its share of the SSI supplement annually to reflect cost of living changes, we respectfully believe that a higher level of state subsidies are necessary to assure continued quality care for our most needy residents. Some of our members are members of the Pennsylvania Health Care Association and Pennsylvania Association of Non-Profit Homes for the Aging. As Beaver County Personal-home care operators we are proud of the quality care we provide for our elderly residents.. We look forward to discussing this important issue with you and other area state representatives throughout our region. Your colleagues across the Commonwealth will be hearing the same message over the next few months as we collectively work towards fair and equitable funding for our neediest residents.

I don't think there be an over-crowding of jails, if some would be sentenced under this, and if it was publicized so others would know, I think there would be fewer crimes committed.


The above suggested law would put the burden where it belongs and would help the police; instead of making new laws to take guns away from lawabiding citizens.

# WHAT TAX REFORM MEANS TO YOU



The Pennsylvania legislature has approved a landmark legislative package that will change the face of local taxes in the state for the first time in decades. It is designed to give local governments a broad mix of taxes to choose from so that they can meet their responsibilities to you and keep taxes as fair as possible. The package is designed to make our tax system fairer, by cutting property taxes and doing away with nuisance taxes. This will reflect more on people's ability to pay than on the worth of their property.

As with any changes involving taxes, the issue is often complex and sometimes confusing. This is designed to help you understand what is contained in the local tax reform package.

# YOU HAVE THE FINAL SAY ON TAX REFORM

Although the House and the Senate have approved methods for reforming local taxes, the public must vote to approve the changes. People can decide whether they like the changes in the May primary. If the changes are approved, school districts could implement their portions of tax reform July 1, 1990 and counties and municipalities could begin their changes Jan. 1, 1991.

# **PROPERTY TAX CUTS**

School districts and municipalities that enact a personal income tax would cut residential property taxes by at least 25 percent. Exceptions to this reduction are: financially-distressed municipalities; school districts or municipalities levying the income tax at the maximum rate; and school districts or municipalities in which the local tax study commission recommends a residential property tax reduction of less than 25 percent. Municipalities could charge up to a .75 percent personal income tax and school districts could charge 1.5 percent. Any new revenues raised from personal income tax rates must be used to cut residential property taxes dollar for dollar.

# **ABOLISHED TAXES**

This legislation would abolish the so-called nuisance taxes such as the personal property, per capita and occupational assessment taxes.

# **COUNTY SALES TAX**

Counties have the option to impose a .5 percent sales tax, except for Philadelphia and Allegheny counties, which could charge a 1 percent tax. No big bureaucracies would be created to collect the tax because the state would collect it along with the state sales tax. Only items that the state charges sales tax on could be taxed by counties.

Also, if a county imposes a sales tax, it must share one-quarter of the proceeds with municipalities that 1) ask to share in the tax revenue 2) establish at least a .25 percent personal income tax and 3) charge a property tax.

Municipalities also could charge up to \$20 for a municipal service tax. This tax is really the occupational privilege tax renamed to better describe its purpose. Municipalities and school districts may exempt low-income residents and eligible senior citizens from the municipal service tax and the personal income tax.

# **INCOME THAT WILL BE TAXED**

Taxpayers will pay their local income tax on the same base as they now pay their state income tax (on wages, net profits, dividends, etc.) THE PERSONAL INCOME TAX DOES **NOT** INCLUDE RETIREMENT BENEFITS SUCH AS SOCIAL SECURITY, WELFARE BENEFITS, UNEMPLOYMENT COMPENSATION OR OTHER INCOME THAT IS NOT TAXED BY THE STATE.

# **SENIOR CITIZENS**

Senior citizens who own their homes and even renters will benefit from the shift away from property taxes. With tax reform, interest earnings and other unearned income will be taxed, but **NOT** pension or Social Security income. There also will be provisions to help protect senior citizens of modest means from both the personal income tax and any increases in their property taxes. Senior citizens, like everyone else, will no longer be subject to the per capita, occupation assessment, residence and personal property taxes.

### HOW THE STATE WILL HELP WITH THESE CHANGES

The state has already set aside \$140 million to be used as a tax reform transition fund. A total of \$70 million will be used during the first three years to help municipalities enact the changes. The remainder will be used to ease the state budget into the other tax-related programs, including:

- ✓ more mass transit assistance;
- $\checkmark$  funds for municipalities declared financially distressed; and
- $\checkmark$  temporary special aid to communities that lose a certain percent of their real estate tax revenues due to business bankruptcies.

# **REMEMBER.** . . YOU have the final say on whether this package actually becomes law!
