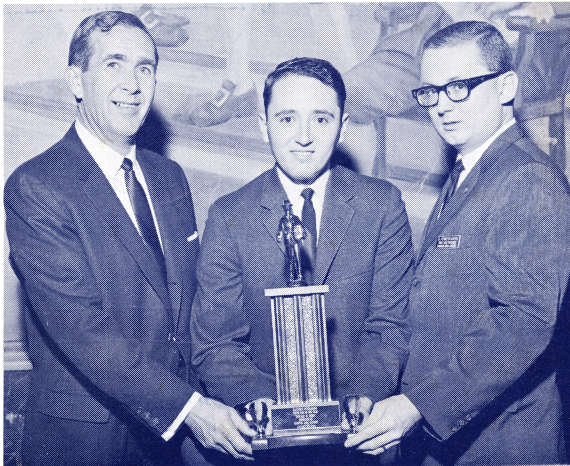

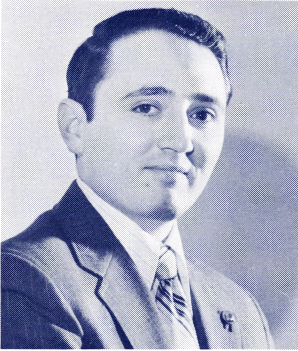
A Church Leader . . .

While attending George Washington University Law School in Washington, D.C., he served on the staff of a Republican Congressman and a Republican Senator. Within two years of moving to York County, Don became the Republican Committeeman in one of the largest Republican Wards in the County, one which consistently produces large Republican majorities for GOP candidates. Don was elected Committeeman in 1966, 1968 and 1970 and served as Hanover area coordinator for the state Republican ticket in 1966. He is a member of the Hanover and Penn Township Republican Clubs and has been active in the York County Men's Club, serving on the ushering, ticket and advertising sales committees for the annual fund raising dinners.
