Harrisburg, January 12, 1984 -- State Representative Don Dorr, R-York, announced today that he will be a candidate for election to the State House of Representatives from the 193rd district.

Dorr is Minority Chairman of the Professional Licensure Committee and a member of the Business and Commerce Committee. He also serves as Minority Chairman of the Subcommittee on Small Business.

Dorr said, "The opportunity to represent the citizens of York County and the Commonwealth has given me the chance to do the kind of work which I believe is the most important of life -- serving others. Therefore, I look forward to this year of campaigning among my constituents for their continuing support and confidence."

Dorr's legislative work boosting the economic climate for Pennsylvania's small businesses resulted in his being named as a National Small Business Advocate of the Year by the United States Small Business Administration. Dorr said, "Small business is the area of our economy in which new jobs will be created. It is essential to make Pennsylvania an attractive place for this to happen." In addition to Dorr's legislative package for small business which was enacted at the end of 1982, the State has just

enacted "Subchapter S" legislation for small corporations. "This was the highest priority item for small business in this Session," Dorr said.

The Professional Licensure Committee has been deeply involved in the "sunset" process. This is the result of a law which requires review of all the boards and commissions established by the State to determine whether they are still needed. Dorr said, "This process is very important as it encourages the updating of old laws and a very critical look at whether the law is really necessary."

Dorr indicated that the seniority and experience he has gained by past service provide an ever-increasing ability to serve his constituency.

"One of the most frequent comments I receive from constituents," Dorr said, "is how much they appreciate 'THE DORRBELL,' my periodic newsletter."

Dorr, along with other York County Members of the General Assembly, maintains an office in York where constituents can call him to voice their opinions on issues facing the Legislature and seek aid in dealing with state government problems they might have. The phone number is 848-1653.

In addition to that office, Dorr added that he can be called at his home or office in Hanover, 637-3231 or 637-8132, or his office in Harrisburg, 783-8875.

Dorr has been active in Jaycee work, having served as local president and state officer. He has also participated in United Fund, Cerebral Palsy, Red Cross and many other civic endeavors.

He is a member of the First United Methodist Church in Hanover,
the Masonic Lodge, and the Hanover Lions Club.

The 193rd Legislative District, reapportioned in 1981,
includes Hanover and New Salem Boroughs and Penn, Heidelberg,
Paradise, Jackson, West Manchester and Spring Garden Townships.

Dorr is married to the former Helen Pfeffer and they are the
parents of a 16-year-old son, Erik. They reside at 305 Charles



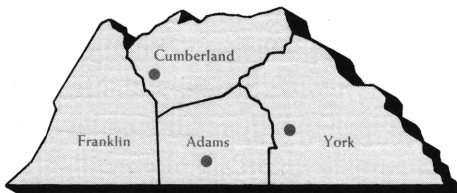

GROUND RULES FOR MEETING

- 1/ Each candidate will have 2 minutes to introduce himself/herself and address the audience.
- 2/ The candidates will make their own introductory comments in alphabetical order by office.
- 3/ After the introductory statements, the moderator will call for questions from the floor. Questions may be directed to any or all of the candidates. They should be concise and limited to questions rather than comments.
- 4/ Each candidate will be allowed 2 minutes maximum to answer questions addressed specifically to him/her. His/her opponent will be permitted 1 minute to respond.
- 5/ All candidates will be allowed 1 minute to answer questions not specifically addressed.
- 6/ The order in which candidates for each office answer questions will be alternated.
- 7/ A timekeeper will signal the end of time allowed. A warning of 30 seconds will be given prior to the end of the period.
- 8/ Only one candidate may speak at a time.
- 9/ Any inappropriate or abusive language will be ruled out of order by the moderator.
- 10/ The moderator's decision is final.
- 11/ In lieu of a closing statement, an informal period after the meeting will be provided for personal questions.

QUESTIONS FOR INTERVIEW WITH ADAMS ELECTRIC COOPERATIVE

1. Energy Tax Incentives

Do you support legislation providing tax incentives to consumers to encourage the installation of energy conservation and energy management measures such as groundwater heat pumps, solar panels, dual-fuel furnaces, and heat storage units to reduce our dependence on imported fuels?

ANSWER

Yes. I believe that the energy crisis we've heard so much about several years ago is still with us. We still need to be concerned about it and encouraging in every way possible the development of alternative fuels, so I would favor tax incentives for the development of those alternative fuels.

2. Public Preference

Do you support legislation that would provide preferential rights to municipal and other nonprofit power suppliers in the leasing and development of state-owned dam sites for hydropower generation?

ANSWER

Yes. One of my goals and aims in terms of legislation having to do with energy is to provide my constituents, particularly, and Pennsylvanians, generally, with electric energy or any form of energy at the lowest possible cost. Therefore, I would have to vote for the cheapest and most efficient methods of producing that energy. If this particular proposal would lend itself to that goal, I would certainly support it. I am not familiar enough with how the technicalities would work in terms of the ultimate cost to the consumer.

3. Farmland Preservation

Pennsylvania is finding that its number-one revenue producing industry - agriculture - is being infiltrated by foreign markets and that a vast amount of Pennsylvania farmland is being bought by foreign investors. Do you support legislation that would reduce the amount of Pennsylvania farmland a foreign investor could purchase?

ANSWER

Yes. I think the preservation of the family farm for the long-term is a goal that is very worthwhile and one we should be supporting as a matter of public policy. I would be concerned about complying with the Federal Constitution and that the laws we would develop would hold up in court, but I would certainly support the proposal to limit in some way the amount of farmland being purchased by foreign investors.



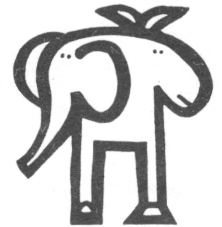

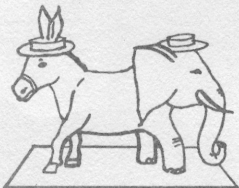

FORMAT FOR "LET'S TALK" MEET THE CANDIDATES PROGRAMS

Each candidate will be given three minutes at the beginning of the program to tell York Countians a bit about himself/herself and what he/she feels are the most important issues leading up to the November 6th general election in York County.

After the opening statements and a commercial break, callers will direct their questions to the candidates. The candidate to whom the question is directed will have two minutes to respond to the question, after which the other candidate will have one minute to also respond to the original question or rebut comments made by the original candidate. The candidate who originally answered the caller's question will then have one minute to respond to the second candidate's comments or rebuttal.

Each candidate will have two minutes to make concluding remarks.

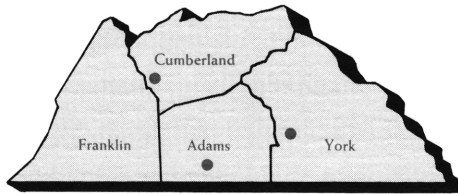
