Zug Vietnam Veterans Plate To Become Reality

HARRISBURG – All Pennsylvania veterans of the Vietnam War will soon have their own special license plate as a result of legislation sponsored by Rep. Peter Zug (R-102), which passed the General Assembly yesterday.

Under the measure, all veterans who have the Vietnam Service Medal may now apply for the special plate at a cost of \$20 in addition to the annual registration fee for their vehicle.

Currently, two Vietnam special plates exist but veterans must be a member of the Veterans of Vietnam War, Inc. or Vietnam Veterans of America in order to apply for the plate. Zug's legislation allows all Vietnam veterans to apply regardless of their memberships or affiliations.

"All Vietnam veterans deserve the right to have a special plate whether or not they belong to a veterans group," said Zug. "There are no such restrictions on veterans of World War II, Korean War or Gulf War. These special license plates are a way for us to honor our veterans, all of whom deserve the right to own one."

Zug said his legislation was included as part of a comprehensive transportation bill which contained over 200 provisions emphasizing the safety and efficiency of the transportation system and enhancing the accountability of PennDOT.

The measure passed both chambers during the final hours of the 1997-98 legislative session and is expected to be signed by the governor # # #

Ridge Signs Zug's Vietnam Veterans Plate Bill

HARRISBURG – During a ceremony today at the state Capitol, Gov. Tom Ridge signed into law legislation sponsored by Rep. Peter Zug (R-102) allowing all Pennsylvania veterans of the Vietnam War to obtain their own special license plate.
