TO: ALL MEMBERS

RE: Sexual intimidation of a child
DATE: January 14, 2003

I am re-introducing legislation to create the offense of sexual intimidation of a child.

The need for such a statute was made clear to me by the mother whose child was intimidated by another and then photographed naked. Because this act was committed to intimidate, as opposed to gratifying another person sexually, a prosecution could not go forward. To this day, the guilty party remains unpunished.
