Dear Representative Cappabianca:

As requested in your earlier correspondence and in light of the serious nature of potential problems, I previously ordered an immediate study of the Erie Civic Center site to determine if a subsurface hazardous waste problem exists. I have just received the results of this study.

There are ten subsurface gasoline/oil storage tanks in the vicinity of the old Sears Service Center. There is no evidence of leakage from any of these tanks. Some still contain gasoline or oil.

Since the gasoline and oil is confined to the tanks, there is no present risk to the public. Notwithstanding this, I am of the opinion that these tanks should be removed. In accordance with the provisions of the Storage Tank and Spill Prevention Act, passed in August of 1989, if we intend to leave these tanks in the ground, we will have to take steps to insure that there will not be any leakage in the future. It is more practical for us to remove them completely.

I will immediately commence efforts to arrange for the funding and authorization to remove the ten tanks. I will keep you appraised of my progress.


