However, please be assured that actually instituting any such fees is not within his administrative jurisdiction. When the Legislature passed Act 242 in 1984 we mandated that any and all fees must have Legislative approval.

While it may appear to be a good way of raising funds to care for and support the park, I have always opposed any move to charge user fees at our state parks. I firmly believe that our parks should be accessible to all who want to enjoy them and no one should be turned away or discouraged by having to pay a fee. If you want to enjoy the sunset over Lake Erie at Presque Isle, you shouldn't have to pay for it.

Should Secretary Oliver come to the Legislature for support on this fee, I am afraid I will not be able to give him my vote.

Section 3. This act reestablishes the State Farm Products Show Cor sion in accordance with the procedures set forth in section 7(a) of the December 22, 1981 (P.L.508, No.142), known as the Sunset Act.

Section 4. The presently confirmed members of the existing State Products Show Commission, as of December 31, 1984, shall contin serve as board members until their present terms expire.

Section 5. Each rule and regulation of the State Farm Products Commission in effect on December 31, 1984, shall remain in effect afte date until repealed or amended by the commission.

Section 6. This act shall take effect January 1, 1985.

The Secretary of Agriculture shall be chairman of the commission, and the commission shall elect a secretary and a treasurer who need not be members thereof. The same person may be secretary and treasurer of the commission.

[Five] Six members of the commission shall constitute a quorum.

Section 1709. State Farm Products Show Commission.—The State Farm Products Show Commission shall have the power, and its duty shall be:

- (a) To formulate plans for, and conduct and manage, exhibitions, to embrace exhibits of all agricultural, industrial, and artistic products, including exhibits of all classes of farm products, embracing [live stock] livestock, dairying, horticulture, all classes of manufacture, industries, and domestic arts, and such other exhibits as will best advance the interests of agriculture and the other industries of the Commonwealth;
- (b) [Until such time as the Commonwealth shall acquire a permanent site therefor, to lease the necessary premises for holding said exhibitions, and to sublet said premises to exhibitors, including the departments, boards, and commissions of the State Government;
- (c) After the Commonwealth shall have acquired a permanent site for holding said exhibitions, to] To lease space to exhibitors, including the departments, boards, and commissions of the State Government, and to lease the Farm Show [Building] Complex, at any time, to individuals, associations, or corporations, for exhibitions, conventions, or other proper purposes;
- (c) To develop, update and make recommendations regarding a longrange plan for needed capital improvements at the Farm Show Complex;
- (d) To oversee the annual capital inventory of the Farm Show Complex conducted by the Bureau of Farm Show to assure policies and procedures of the Department of Agriculture are employed in conducting the inventory and update.
- To arrange for the holding of meetings for the promotion of agriculture.
- Section 2. Section 1920-A(f) of the act, amended July 1, 1981 (P.L.177, No.51), is amended to read:

Section 1920-A. Environmental Quality Board.—* * *

(f) The board shall establish such rules and regulations, not inconsistent with law, for the control, management, protection, utilization, development, occupancy and use of the lands and resources of State parks, as it may deem necessary to conserve the interests of the Commonwealth. Such rules and regulations shall be compatible with the purposes for which State parks are created. Whenever the board imposes fees or charges for activities, admissions, uses or privileges, including charges for concessions, at or relating to State parks, such charges or fees shall be used solely for the acquisition, maintenance, operation or administration of the State parks systems, and are hereby appropriated for such purposes. The board shall not adopt or impose any charges or fees for parking or general admission to State parks unless the charges were imposed prior to January 1, 1984. The board may continue to impose and modify parking charges and fees applicable to specific services or units within the State park system which were imposed prior to January 1.

Secretary Arthur A. Davis has asked me to thank you for forwarding Mr. Greg Gorniak's letter regarding the Resources Management Plan for Presque Isle State Park. We have acknowledged Mr. Gorniak's previous letter to Secretary Davis.

Presque Isle State Park's mission is two-fold: to provide healthful outdoor recreation and to protect the natural resources. At times, these points may be in conflict with each other and we must carefully review all factors.

Since the Bureau of State Parks held the January 7, 1993, public meeting in Erie to receive comments about the draft plan, we have been receiving letters addressing both sides of the issue. As we delve into the structure of the committees that were charged with formation of the Presque Isle Management Plan, it becomes evident to the lay person that this was a plan engineered by a few to satisfy the goals of a small selective group. The letter you have from Rich Weber, a committee member on Phase III Gull Point, the affidavits and letter from Attorney Greg Sesler, the lack of committee attendance reports and the lack of notification of meeting notices to the various committee members, coupled with the lack of identification of the authors of the final plan, support the premise that some of the prescriptions were biased.

I realize that a great effort was expended to draft this plan, but many of the main prescriptions are based on assumptions rather than fact. There are no ammendments or scientific information attached to the plan to substantiate the prescriptions for Gull Point.

If you study the makeup of the Presque Isle Advisory Committee and recognize how many people from this group were involved in multi-plan committee functions, it becomes crystal clear that these committees were not represented by a cross section of the various groups that use these park areas.

The structure of the existing Presque Isle Advisory Committee does not represent a cross section of the people who use this park.

Therefore, we the sportsmen and boaters who contribute over \$600,000.00 in fees at Presque Isle, ask you, our legislator, to investigate the manner by which appointments are made to this advisory group. We would further ask that you take action to increase this group by four seats, two of which would be held by the duck hunters and two which would be filled by boating representatives. Resumes of applicants will be furnished upon request.

Having dealt with you during the formative stages of the Presque Isle Marina Association, I hope you will realize that this committee is not representative of the Pennsylvania citizens that utilize this facility.

Secretary Arthur A. Davis has requested me to respond to your letter of September 22, 1992, regarding marina fees at Presque Isle State Park.

The Bureau of State Parks is proposing adjustments to a number of fees on a statewide basis. At Presque Isle State Park the fees will be affected by a decrease in the winter storage fee from the approved 1992 rate of \$15 per foot to \$12 per foot for a Pennsylvania resident and from \$30 per foot to \$24 per foot for a non-resident of Pennsylvania. The travel lift fee will be reduced from the current \$5 per foot to \$3.50 per foot for a Pennsylvania resident and from the current \$10 per foot to \$7 per foot for a non-resident. These two fees were decreased by the Director of State Parks for the 1992-93 storage season under authority of Subsection 31.164 (3),(b).

Prior to the 1992 rate change, the Presque Isle State Park marina rate charged was based on the foot of stall assigned. The 1992 schedule listed the rate as cost per foot of boat. When the marina tenants were billed for the 1992 season, they were originally charged by the stall assigned as had been done in prior years. It was then pointed out by the marina tenants that the charge was to be by the foot of boat as was published in the Pennsylvania Bulletin. The Bureau of State Parks, therefore, processed refunds for the overcharges.

We are proposing to return to a charge based on per foot of stall assigned. With this recommended change approximately 165 of the 473 Presque Isle State Park marina tenants will be affected. The amount will be the difference between the length of boat and the size of stall assigned. Slips using the bascomb holders will not change.



This change will help us administratively in producing accurate billings and reduce the need to process refunds. change is also in line with the standard practice used in the boating industry today. It allows us to efficiently assign boats to appropriate size stalls without loss of revenue. It provides new tenants with a known cost when they are awarded a slip before they own a boat. The change will also eliminate the difficulty encountered in determining the chargeable length of boat.

The last change that is proposed for the fees at Presque Isle State Park marina is the water and electric fee. Presently, each fee is listed separately as \$1.50 per foot of boat resident and \$3 per foot of boat non-resident. utilities are offered together on two piers. The change combines these two rates with the \$30 marina fee resulting in a new marina with utilities fee of \$33 per foot of stall for residents and \$66 per foot of stall for non-residents of Pennsylvania.

In summary, the rumor that there is going to be a 50 percent increase in fees is not true. The proposed adjustments decrease some fees and change the method of calculating the marina fee from length of boat to length of stall. The adjustment will affect some of the tenants in the marina.

Prior to the fees being published in the Pennsylvania Bulletin there will be a 30-day public comment period. Bureau will issue a press release regarding all fee changes to inform the public of the comment period. You will be sent a copy of the proposed changes before that time. We welcome any comments you may have and will give them serious consideration in the final package.

It is heavily rumored in the Erie area that there is yet another fee increase to be implemented at Presque Isle State Park next year. This increase would come in two forms. One would increase slip fees an additional 50% for the 1993 season, and the other is a planned change in the manner of rate basis from "per foot of boat" to "per foot of stall".

I would think it is obvious that the boaters in Erie could not, and would not, withstand such an increase, particularly falling directly on the heels of this years' drastic increases. Certainly, I can understand the need for additional revenue, however, I can not support such a repeated "taxation" of the same sector of the public.

While I am aware that this possibility came to me only in form of a rumor, I feel it is incumbent upon me to seek confirmation, or repudiation from your office. Any information and assistance you can lend me would be appreciated. Thank you.

URGENT

Dear Representative Cappabianca;

Please support a proposed winter storage rate decrease.

Please investigate a rumor the Bureau of State Parks has plans to increase slip lease fees by 50 % for the 1993 season.

Please oppose a change in the rate basis from "per foot of Boat to per foot of stall

RATE REDUCTION:

Please advise the Bureau of State Parks, Department of Environmental Resources and if necessary The Environmental Quality Board of your approval and support of an initiative by the Presque Isle State Park Administration to reduce winter storage rates to a 20% increase over 1991 from an established 50% increase.

This "eleventh hour" change comes just days before the contracts or leases for winter storage must be prepared and therefore it is urgently required that the Bureau give their approval.

The minutes of the last Park Marina Committee (August 27, 1992) have been posted in the Marina rest rooms (the Park Administration won't communicate or deal with the Association). These minutes state the "Park has requested a reduction to the established winter storage and travel lift fees. The proposed fee for winter storage is \$12.00 and \$24.00 (resident and non-resident respectively) per foot of boat versus \$15.00 and \$30.00. The proposed travel lift fee is \$3.50 and \$7.00 per foot versus \$5.00 and \$10.00 storage to \$12.00 from \$15.00".

The Association believes this rate is still excessive to store a boat in an unguarded, seasonally unused parking lot for which the only services provided are the boat lift out in the fall and lift in next spring. Since many boaters have no other options and we therefore consider the revised rate more tolerable.

We find it implausible to believe the Park Administration rate reduction request to be an act of benevolence but on the contrary has probably been precipitated by the lack of response to storage sign up (38 based on a recent check compared to 100 boats stored for the winter of '91-'92). The marina by the way has 498 slips. Tenants are pursuing other

options such as storage elsewhere and others have found a trailer purchase to have sufficient economic pay back. This is not a totally elastic market. Sometimes you generate more revenue by cutting prices and increasing volume than increasing rates and losing total revenue.

LEASE FEE INCREASES

Please investigate whether there is any substance to the rumor, reported at our last Association Meeting, that the Bureau of State Parks is planning to increase the seasonal slip rate by **50%** for the 1993 season.

About this time in 1991 we heard similar rumors of an impending rate increase. At that time there was no alarm since most tenants felt an increase was merited. But never in our wildest imaginations had anyone anticipated anything beyond 20 %. This time we hear the gun being loaded and we don't want to get blasted again. We don't feel that there was any justification for the last increase and there should not be another increase for a number of years to come. Remember in the last nine years the fees have gone up 429%. There are no other criteria, cost of living, inflation rate, etc. that have increased to this extent.

You may also be interested in knowing that 68 tenants did not renew their leases this year and after a full season of trying, the Park Administration still has not been able to lease 28 slips (August 27,1992 minutes). This apparently substantiates the long waiting lists that have been used to justify the take it or leave attitude are the reflection of the aspirations of people in the long term. They do not reflect the reality that the price of a slip can become a barrier to achieving these aspirations, and that these are economically poor times for may people including those who had a desire to enter boating and those that had planned on trading up.

It is also interesting to note the dinghy rack which can hold approximately 28 boats and in years past was full, had only 6 boats this year.

Please keep us informed.

RATE BASIS

We also request that you express our and hopefully your opposition to a request to change the fee basis from a "per foot of boat" to "per foot of stall".

The afore said minutes also state "Pete (John M. Houghton, Park Manager) has also made a request to Harrisburg to return to charging based on per foot of established stall size versus "per foot of boat", but with the misprint in the Pennsylvania Bulletin, the park felt it necessary to charge accordingly".

We oppose this change since it represents an increase in rates to many boaters. Secondly, the State already is guaranteed a minimum return from any slip based on the lower limit set on boat size for a given established stall size. Finally, under the present basis the state can rectify an inequity that has existed for many years, where oversized boats have occupied and paid for a smaller stall because of "grandfathering" stemming from a definition change in boat size limits for a given stall size. Some boaters have been refused a stall or have been forced to mutilate their boats to avoid losing a stall by cutting and reshaping bow rails or cutting off bow pulpits, etc..

One of the reasons given for returning to the "per foot of stall" basis is to simplify lease preparation. In this age of computer utilization this should not be a problem. Using a computer the fee can be easily obtained by allowing the computer to do the multiplication for converting the boat length to rental amount. Boat length information exists in lease and application documentation.. Presumably in the act of managing the marina the boats occupying the slips are checked to assure it has the corresponding PA registration number, and meets the size description, etc. The data base can also be sorted by any of the fields or combinations, name, pier, stall, length, address, zip, home phone, business phone, type, manufacturer, year etc.

If the Bureau of State Parks does insists on charging based on stall length then we feel it only reasonable that the Park Administration drop the minimum length criteria, It should then be of no concern to the Park that an individual who pays for a slip have a boat in the slip or that the boat meets a minimum size. Their concern should be that it does not exceed the maximum. This would allow tenants to trade up when they find the boat of their choice and when their finances allow this move and not be pressured by some meaningless deadlines.

For the record, the Park issued 1992 leases on a by "per foot of stall" basis and it was this Association by letter from its President dated February 21,1992, that called the Park Administration attention to this apparent inconsistency and violation of its own regulation. The Park has subsequently issued refunds however these were done on the basis of the nearest boat half foot (six inches) although the precision used for determining slip size eligibility is the nearest twelfth of a foot (inch). Its funny how criterion never applies in your favor.

We were only able to detect this error by reading the regulation as printed in the Pennsylvania Bulletin made available to us by Representatives Boyes' office.

For the record also, we also take issue with the so called "misprint" of the basis. This criterion appeared in an attachment to a letter to Representative Merry date December 23, 1991, it appeared in the Pennsylvania Bulletin dated December 28, 1991, a Department of Environmental Resources news release dated January 29, 1991, and probably other internal documentation. Apparently no one in the Bureau proof reads or reads their own documents. They made us believe the rate change, due date and we believe they also meant the basis for levying the rate. Its funny how criterion never applies in you favor.

Representative Merry recently took me to task for the Association not be proactive at the time the regulation was being formulated. My response is that I/we thought our Legislators were watching out for their constituents interests. The record shows the Bureau issued a "notice of proposed rule making was published at 20 Pa.B 6359 (December 22,1990) and included a 60-day public comment period." It would seem that any actions being taken which might impact on Presque Isle State Park and its 3.5 million annual visitors should have been worthy of note by our Legislators. Not one Legislator caught the impact until the deed was done a year later. This Association was formed January 31, 1992 as a result of the regulation changes, in the belief we might be able to help pull the "fat out of the fire". We didn't exist to act proactively and had no reason to exist. Our naivety shows how wrong we were in thinking the citizenry has a voice individually, jointly or through our legislators in the bureaucracy's actions

One more just for the record! For the estimated increased \$130,000 in Park revenue the tenants got cleaner rest rooms, something that should have been all along, but at least it should be noted. Beside this simple dignifying action and that we did get some new picnic tables we got zippo!

We asked to have the rest rooms secured and the membership voted for a magnetic key system. The Marina Committee Minutes read "Members (Marina Committee Pier Reps) were to survey tenants. There was mixed input as to desire. A true consensus could not be made". Our Association vote on the subject obviously was not communicated to the Administration by the Pier Reps. It was reported to the Association that one woman was flashed by a male at the west rest room. The Pier Reps (Committee) have no line of communication with the tenants. Until the Association suggested to the Pier Reps that the Park install some type of placard identifying the Pier Rep most tenants did not know they had one (actually two). The Association has a 200 plus (approaching 50%) membership. We also asked to have the picnic areas which are sandy gravel seeded with grass. A \$6,000 (?) Project was submitted by Administration but not a seed has fallen.

If we sound frustrated, we are, but we'll keep trying because we know we can make changes happen.

We hope we can count on your support at this time and we look forward to working with you. We welcome the opportunity to have you at our meetings. We'd love to have a knock down, drag out, lay the cards on the table, problem solving session, with the Erie Delegation.

Dear Secretary Davis:

After meeting with Superintendent Harry Leslie and learning that the general public would shortly be informed of the upcoming increase in user fees for the State Parks system, we must confess our disappointment and concern. While we certainly understand the need for the additional funds, we are concerned with the manner in which the increases were posted.

It seems a more prudent and fiscally considerate process would have been to increase said fees incrementally. We agree and understand that fees have not been raised since 1986, however we point out that this lapse has been at your prerogative. No one denies that inflationary necessities require periodic increases, however arbitrarily doubling fees in one stroke lends everyone to criticize the process.

In addition, permit us as a delegation, to be somewhat parochial when it comes to Presque Isle, which we all consider special, and we tend to become somewhat protective. Due to the nature of the weather conditions of the northwest and the freezing of the Erie Bay, most boaters use the Marina no more than 6 to 8 months a year. Whereas boaters in other state parks have the advantage of a full 12 month season for their annual fees. One might ask, was this fact considered when the fee schedule was devised?

With regard to the fee structure remaining lower than private marinas, we have no argument there. However, this argument can not be used forever. The fact remains that private marinas exist, and will always have their clientele. The Commonwealth's marina is designed to further facilitate use of the State Park by residents who might otherwise be unable to enjoy the luxury of boating. We can not ignore our obligation to these people, and use fee differentials of private versus public marinas as a reason for increasing fees. If we are to use the argument of unfair competition, public versus private, to its logical conclusion, one could surmise that the state should not be in the marina business at all.

Essentially, we ask your careful consideration of the residents of Erie County when implementing further user fees. Perhaps in upcoming years periodic increases balanced with consideration of the climatic limitations of the area could be incorporated into the fee schedule process.

Thank you for your kind attention to our concerns. We are, as always, appreciative of your Department's interest in the Presque Isle Superintendent Leslie, is most helpful in addressing our inquiries. We feel confident that, for the most part, your staff is working in the best interest of the park and are grateful for that. Thank you.

Secretary Arthur A. Davis has asked me to respond to your letter of December 23, 1991, commenting on increased marina fees and state park fees in general at Presque Isle State Park.

I appreciate the support which is indicated by your letter. The statement that "a more prudent and fiscally considerate process would have been to increase said fees incrementally" is a point well taken. The effort to receive approval for the new state park regulations which contained the current approved fees began almost three years ago. Because of the need, by law, to be reviewed and approved by numerous individuals, as well as a number of boards and commissions, the approval process became quite lengthy. In an effort to eliminate such a time lag in the future, state park regulations will still be required to go through the entire process, but fees will not. In the future, requests for fee increases will have to be approved by the Environmental Quality Board and, therefore, will be implemented in a more timely fashion.

The Presque Isle State Park operated marina operating season is comparable to those of other state parks operated marinas. None of them are available for year-round use. The marinas at Presque Isle, M. K. Goddard, and Prince Gallitzin State Parks operate from May 1 to October 31. Two parks have a shorter operating season than Presque Isle State Park. Bald Eagle State Park marina operates from May 15 to October 31 and Shikellamy State Park marina operates from May 15 to September 15. The remaining four state park marinas at Codorus, Moraine, Neshaminy and Nockamixon operate from April 1 to October 31. The various seasons are required because of local considerations such as impoundment drawdowns, dock removal, etc. Because of the similarity of the season lengths, no adjustment of rates were considered based on this factor.

An important result of the fee increases is that the money will be returned to the Bureau of State Parks for the operation and maintenance of the 114 state parks. This will, I am sure, result in additional funding being made available for necessary projects at Presque Isle State Park.

I appreciate you expressing your thoughts as a delegation and assure you that the Department of Environmental Resources as well as the Bureau of State Parks recognizes Presque Isle State Park as being one of the "gems" of the Pennsylvania State Park System. Thank you for your continued support.

SUBJECT: State Park Fees

In the near future, I plan to introduce legislation which would address the manner by which the Environmental Quality Board (EQB) may effect an increase in fees and charges relating to the use of state park recreational facilities. Specifically, the legislation would amend the Administrative Code to require the EQB to make all fee changes via regulation and pursuant to the procedures established by the Regulatory Review Act.

Under present statutory law, the Administrative Code empowers the EQB to impose fees and charges for state park use, but does not explicitly require that such fees/charges be adopted through the regulatory review process, as conducted by the Independent Regulatory Review Commission (IRRC). As a result, the EQB is authorized to increase fees/charges based on internal decision-making, without the benefit of a thorough, independent cost and benefit analysis by IRRC, and without the benefit of effective legislative input as provided by the regulatory review process.

The proposed legislation would clarify the language of the Administrative Code to specifically require that EQB adhere to the procedures of the Regulatory Review Act when making changes to the fees/charges imposed for the use of state park facilities.

The recent 94% increase that you and your fellow board members have instituted for the boating tenants of the Presque Isle State Park Marina are not consistent with the graduated increases initiated in the years 1984, 1985, and 1986, nor are they consistent with the percentage increase of 10 to 20% as indicated by Mr. Forrey in your meeting minutes of September 17, 1991.

After checking the new fees of the other 112 facilities within the park system, it is quite evident that the increases have not been applied equally to all facilities across the state. The off shore mooring fees which have never been collected at Presque Isle seem to lend credence to the possibilities that discrimination has been levied on certain segments of the boating and tax paying public of Pennsylvania. The following rates for Erie Marinas were gathered on January 6, 1992, and are recorded here for future reference.
