**Preventing Inmates from Receiving Unemployment Benefits** 

I plan to reintroduce legislation (H.B. 1740) that would amend the Pennsylvania Unemployment Compensation Law to clearly state that individuals who are incarcerated after a conviction are not eligible for unemployment compensation benefits. This legislation is being introduced in direct response to an incident that recently occurred in my district. A Perry county inmate who was on a work release program which was subsequently revoked, was awarded \$2400 in unemployment benefits by an unemployment compensation referee. Section 402.6 of the Law already contains language that was intended to prevent such situations and it is my estimation that the referee clearly erred in his decision. However, in order to provide clear guidance to unemployment referee's, my legislation would leave no doubt to the eligibility of individuals who are incarcerated after a conviction.

### **Egolf Bill Would Deny Unemployment to Prisoners**

HARRISBURG – Rep. Allan Egolf (R-Perry) announced today he has introduced legislation to prevent incarcerated individuals from receiving unemployment compensation benefits.

Egolf said he decided to introduce the bill after it was revealed that a Perry County prison inmate had collected about \$2,400 in unemployment compensation.

"It is unbelievable that a convicted criminal was collecting these benefits," Egolf said. "There is something terribly wrong with the system when this can happen. The legislation I am introducing will deny payment of unemployment compensation for any weeks the person is incarcerated after a conviction.

"Unemployment compensation benefits are intended to assist deserving people who are not working because of job-related circumstances, not because they committed a crime and are locked up. The tax dollars of honest, hard-working people in Pennsylvania are already being used to house, feed, clothe convicted criminals. It is unfathomable to ask the citizens of this state to support incarcerated individuals through unemployment compensation benefits."

Egolf said the benefits paid to the prisoner, Douglas Kroh, are being appealed to the state

Unemployment Compensation Board. Kroh is a drug offender and parole violator who is to be in prison until

July 1998.

Kroh was imprisoned in 1992, was paroled in mid-1995, and was returned to prison due to a parole violation in January 1997. While he was on parole he worked for a garment firm until October 1996. He had applied for unemployment compensation benefits just before and after he was returned to prison earlier this year.

"Hopefully, common sense will prevail in the appeals process and the state can recover the money already paid to the inmate," Egolf said.

## **Egolf Praises Unemployment Compensation Board Decision**

HARRISBURG – Rep. Allan Egolf (R-Perry) today praised a state review board decision overturning a ruling which awarded unemployment compensation to a Perry County prison inmate, and described it as essential to maintaining the integrity of the unemployment compensation system.

"There is no way a prison inmate in this Commonwealth should be receiving unemployment compensation benefits," Egolf said. "These benefits are intended to serve as a temporary bridge for honest people who aren't working because of job-related circumstances, not for those who have committed crimes.

"I would like to echo the governor's sentiments that this is a victory for common sense and decency on behalf of Pennsylvania taxpayers.

"Even with this favorable decision, I will aggressively push for passage of the legislation I introduced Thursday to deny incarcerated individuals from receiving these benefits. This situation must be prevented from happening again."

On Thursday, Egolf introduced House Bill 1740 which denies unemployment compensation benefits to incarcerated persons.

Also on Thursday, the Unemployment Compensation Review Board overturned a state referee's ruling which gave inmate Douglas Kroh approximately \$2,400 in benefits. Kroh is a convicted drug trafficker and parole violator who is serving time in the Perry County prison. Egolf said some of the money paid to Kroh has been recovered by the county to pay for court-related fines.

Egolf explained that Gov. Tom Ridge requested the Department of Labor and Industry to appeal the referee's decision. That appeal led to Thursday's decision.
