Egolf Bill to Give Special Commission Advisory Role to AMVETS Executive Director Is Sent to Governor

Enactment of the bill would give AMVETS executive director non-voting advisory membership on Veterans' Commission

HARRISBURG – The state House today unanimously approved and sent to the governor legislation sponsored by Rep. Allan Egolf (R-86) that adds the executive director of AMVETS to the State Veterans' Commission as a non-voting advisory member.

"This bill recognizes the growing importance of this fine veterans organization," said Egolf. "The commission has worked for this bill for a long time."

Under current law, the state adjutants of the American Legion, the Veterans of Foreign Wars (VFW) and the Disabled American Veterans (DAV) are afforded non-voting advisory memberships in addition to regular voting membership.

"The membership of AMVETS has significantly increased over the years and now totals 16,000 in Pennsylvania," Egolf said. "They deserve the same representation that is currently afforded to the larger American Legion, VFW and DAV.

"The AMVETS do have a voting member on the commission (the state commander)," he said. "We are simply adding the executive director to the ranks of the non-voting advisory membership."

Egolf said the measure in no way affects the AMVETS voting privileges.

AMVETS membership is open to all men and women who have served honorably any time after Sept. 15, 1940, or are currently serving in the U.S. Armed Forces, Reserves or National Guard.

Founded in 1943, AMVETS, which stands for "American Veterans," is one of the most recently organized veterans groups.

The State Veterans' Commission is an advisory body, created by the General Assembly, within the Department of Military and Veterans Affairs.

Egolf is vice-chairman of the House Committee on Veterans Affairs and Emergency Preparedness where the bill was first considered.

Egolf's measure was originally passed by the House on June 5. The Senate passed the bill on Oct. 4 by a vote of 48-0.

The legislation was also amended with a provision that affords employers the option to pay employees who are members of the National Guard or military reserves and are called to war.


