Mauree,

I am introducing a concurrent resolution appealing to Congress to use Article III, Section 2 of the U.S. Constitution to limit the appellate jurisdiction of the federal courts regarding the recitation of the Pledge of Allegiance in public schools.

Recent actions of the 9th Circuit Court of Appeals on this issue violate fundamental constitutional principles and jeopardize a time-honored practice supported by overwhelming majorities in every state. This is not a problem that can be solved at the same level, but this is a problem that states can help solve by encouraging action by Congress. Congressional action is necessary to restore the judiciary to its constitutionally-proscribed role by restraining it from making decisions that rightfully should be left to the legislatures. This action will also help remind Congress that the "Exceptions Clause" is a remedy at their disposal, a remedy that has been used dozens of times in the past but recently overlooked.

The recent decision by U.S. District Judge Robert F. Kelly help to reinforce the importance of this resolution. His 29 page opinion and order make permanent a preliminary injunction blocking enforcement of our law to recite the Pledge of Allegiance. Enough is enough.

I would appreciate your co-sponsorship of my Concurrent Resolution to restore discipline to the courts. Please have your secretary contact my office if you are interested.

PICCOLA & EGOLF BLAST ACLU FOR FEDERAL LAWSUIT CHALLENGING PLEDGE OF ALLEGIANCE REQUIREMENT IN SCHOOLS

HARRISBURG - Senatu Majority Whip Jeffrey Piccola (R-15) and Representative Allan Egolf (R-86) expressed outrage today that the American Civil Libertics Union of Pennsylvania has filed a federal lawsuit opposing a new state law requiring schools to display the American flag in every classroom and to offer either the Pledge of Allegiance or the playing of the National Anthem before the start of every school day.

The lawmakers also are steking clarification of reports that the Department of Education is delaying enforcement of the law, which was to take effect today, pending a federal court hearing on the matter.

The legislators pointed out that Act 157 of 2002, sponsored by Rep. Egolf in the House and championed in the Senate by Piccola, was overwhelmingly approved by the General Assembly and signed into law by Governor Mark Schweiker last December 9.

"Act 157 merely guarantees that Pennsylvania's school students will have the opportunity to recite the Pledge or hear the National Anthem overy morning before their school day begins," said Egolf. "It doesn't force the students to do anything, and in fact gives students who have religious or personal objections to reciting the Pledge the ability to opt out with parental notification from the school."

The ACLU filed the suit on behalf of the Circle School, a private school in Harrisburg, and on behalf of a student.

"I'm disappointed that a school in my district objects to something that requires such a minimal amount of citizenship on the part of its students," said Sen. Piccola. "At a time when the nation seems to be on the verge of war, I can't think of anything more reasonable than Pennsylvania's children having the right to say the Pledge of Allegiance. And for the ACLU to take up this alleged cause under the illusion that it hampers anyone's right to free speech is positively ludicrous."

The legislators noted that Act 157 had strong support from Pennsylvania's veterans' organizations.

"Some people seem to think that encouraging patriotism and respect for our nation is a bad thing, and that's a shame," said Piccola. "Given what's going on in the world, many folks are re-embracing America's traditions and finding strength and comfort in them. Is that such a terrible thing to instill in our kids? I don't think so."

"Pennsylvania's kids deserve to know the pride that comes with patriotism and with loving your country -- especially in the face of adversity," said Egolf.

The legislators said they will follow the case closely and will fight any attempt to overturn Act 157.
