Dear Secretary Phillips:

As Acting Secretary of Education, we trust that you are intimately aware of the recent challenge to Act 157 of 2002 that was filed—regrettably—by the ACLU and Dauphin County's Circle School. As champions of this measure in the General Assembly, we are confident that the law will meet Constitutional scrutiny.

We do wish to seek clarification from you regarding the department's role in enforcing the new law. It was reported in one of the news articles covering the story that Pennsylvania Department of Education attorneys "promised not to enforce the law" until the District Court judge has a chance to hold an injunction hearing and that they had "no interest in enforcing the law immediately." A second article attributed an ACLU official confirming that the department was delaying enforcement. It is with utter bewilderment that we read those accounts.

To the best of our knowledge, Pennsylvania law is not abrogated merely because a suit is filed challenging it nor are administration officials able to voluntarily and gratuitously determine that a law should not be enforced simply because of a court challenge. Act 157 is the law of Commonwealth and it is incumbent upon the affected educational institutions to fully comply with its provisions. The Commonwealth's lead educational agency should not carry such an apparent and cavalier attitude towards compliance. The message that it sends to schools, students and parents alike is that if you do not agree with a law, you do not comply with it until such time as the court decides to address the issue.

We would be happy to discuss this issue with you personally and look forward to your response.

Correct, this was introduced prior to 9/11/01. Rep. Egolf initially introduced this on June 15, 1999 as House Bill 1673. It was reported to the Education Committee but never moved so it died at the end of 2000 when that Session was over.

He reintroduced the legislation as House Bill 592 on February 8, 2001. It was referred to the Veterans Affairs & Emergency Preparedness Committee where it was reported as amendmended on June 20, 2001. It was then put into the Rules Committee. That committee re-reported it as committed on 9/24/01. From there it continued to move through both chambers and was signed into law on December 9, 2002 as Act 157.
