


Dear Mr. Kelly:

The Pennsylvania State Retired Teachers Association wishes to thank you for sponsoring H.B. 672, P.N. 733, introduced March 31, 1971.

This Bill, which has the support of PSRTA and PSEA, is of vital importance to the over 30,000 retired public school employees who retired prior to July 1, 1967 and who did not benefit under Act 261.

Currently the Joint State Government Commission is making an in-depth study on the impact of this bill on the retirement allowances now being paid. The work of the Commission should pin point any inadequacies in the Bill and provide guidance for the drafting of any amendments which their research might deem advisable.

It is the primary concern of PSRTA and PSEA that this proposed legislation provide fair and adequate increases for all retirees, many of whom are currently receiving incomes below the poverty level.

The retired teachers look forward to your continued support of this legislation.

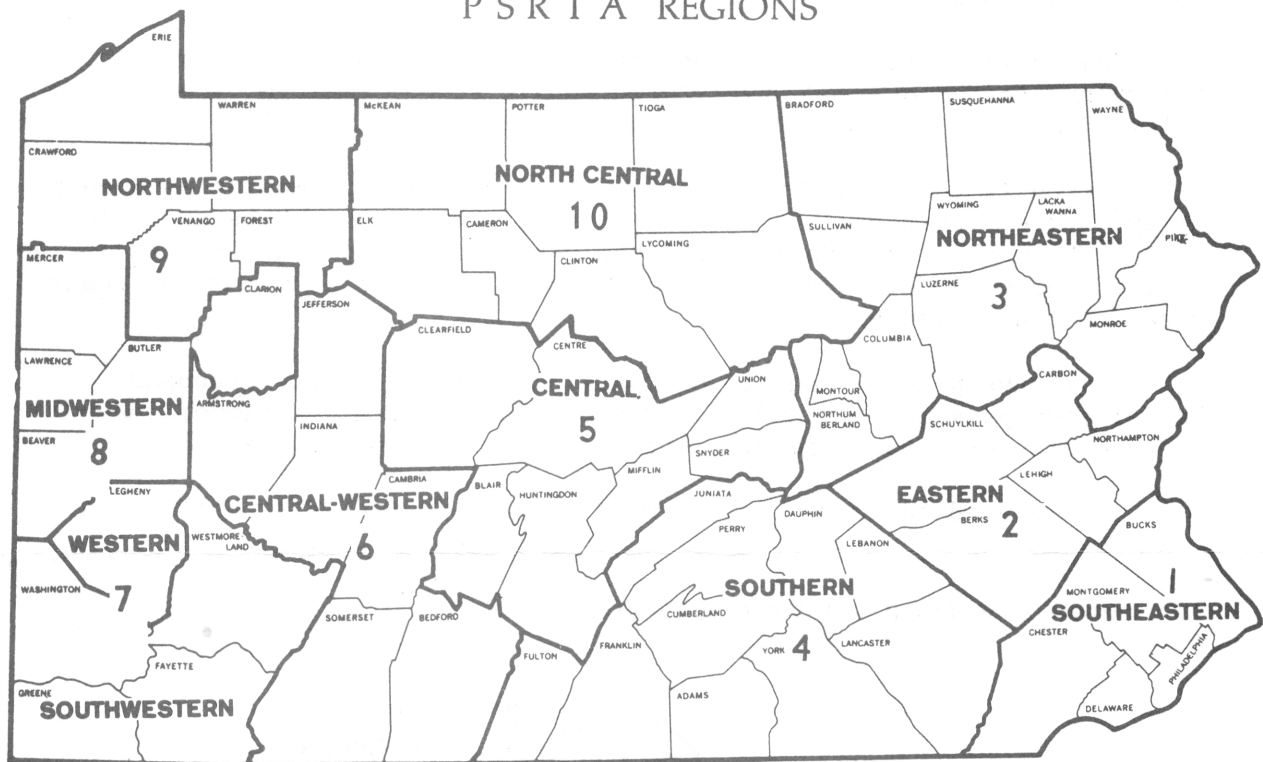
