- -- A 3 percent cost of living adjustment for community mental health, mental retardation and early intervention as opposed to the 2 percent COLA proposed in the Governor's Budget.
- -- An additional \$288, 000 to backfill the reductions in the federal Mental Health

Services Block Grant.

--Support for the Governor's proposal that Pennhurst funding be merged into community mental retardation line item amounting to an additional \$2.7 million.

- -- Their request that all savings achieved through "rightsizing" state institutions be invested in community MH/MR programs.
- -- And their request that the \$1.4 million the Governor proposed for 500 additional children to receive early intervention entitlement services be used to fully fund children already in service.

I am pleased that the Governor's budget requests amounts consistently above the rate of inflation for State Centers for the Mentally Retarded, percent 11.2 increase; an Community Mental Retardation Services, a 7.7 percent requested increase; Intermediate Care Facilities for the Mentally Retarded, an 8.1 percent increase, and an overall General Fund Budget increase for mental retardation services of 7.7 percent.
