We understand that Governor Casey has included funding in his 1989-90 budget to establish two (2) Regional Offices for the Deaf and Hearing Impaired.

As we are sure you are aware, we in Northwestern Pennsylvania have not received the kind of attention in this area that Pittsburgh and Philadelphia have.

Our Deaf community experiences an 85% unemployment rate. Mental Health and interpreting services are painfully lacking.

According to a research report prepared by the governor's Policy Office (8/22/88), in the thirteen (13) counties comprising Northwestern Pennsylvania there are 81,939 Hearing Impaired adults. This, obviously, is a large population that has been neglected primarily because of their inability to make their voices heard.

We have attached the names of the three (3) members of the Advisory Committee for the new State Office of the Deaf and Hearing Impaired. Your immediate intervention is essential if this committee is to be made fully aware of the tremendous unmet needs of your constituents.

Unfortunately, I can not tell you a decision has been made regarding the locations of the first two offices. We, the members of the Regional Office Subcommittee, share your concern over the limited resources available to the Deaf people and Hard of Hearing people in the Northwest section of the Commonwealth. Similar situations exist throughout Pennsylvania for the Deaf and Hearing Impaired populations.

Although the Office for the Deaf and Hearing Impaired has a limited budget for fiscal year 1989/90 all efforts will be made to establish two offices and to provide viable services through those offices to deaf and hard of hearing people.

A decision regarding the geographic location of the Regional Offices should be made soon. I am sure Mr. Duncan will be in contact with you once the decision is finalized.

Please consider the importance of the continuation of the Office for the Deaf and Hearing Impaired and the need for continued state funding at a level allowing the Department of Labor and Industry and the Office for the Deaf and Hearing Impaired to open more Regional Offices throughout the Commonwealth. Your support is greatly needed.

Dear Reverend Kime and Chairperson Silva:

Thank you for your letter of support for Senate Bill 25, which proposes the establishment of a two-year moratorium on the death penalty in the Commonwealth of Pennsylvania. I appreciate hearing from you with respect to this serious and important issue, and I am pleased to have the opportunity to respond.

You have expressed your opposition to capital punishment, and I share your concerns about the need for a moratorium. Indeed, it is known that there have been innocent people that have been put to death who were wrongly accused and convicted. With the emergence of DNA testing, some of these injustices may be able to be avoided.

I believe that we should establish a moratorium on the death penalty until we can further study the critical issues and questions that surround the prosecution of legal cases involving the imposition of the death penalty. To highlight my concern, on April 24, I offered an amendment to Senate Bill1, the General Appropriations bill, to provide \$326,000 to the State Police to expand the capacity of the DNA laboratories and add six additional DNA scientists. The amendment was unanimously adopted by the House.

Senate Bill 25 was introduced and referred to the Senate Judiciary Committee on January 22, 2001. To date, no further formal action has been taken on this legislation. Please know, however, that I will continue to support a moratorium on the death penalty in Pennsylvania.

Thank you for contacting me about House Bill 1394 which provides for the licensing and registration of dentists and dental hygienists. The Professional Licensure Committee of the House is currently reviewing the bill. It is too early to predict what the final content of the legislation will be.

The major concern I have about the bill as it is currently written is that children under nine may receive anesthesia only in a 'hospital setting.' That requirement – because it implies more costly care - can cause parents to delay getting appropriate dental treatment for their children. This is especially true in more rural areas of the state where there are fewer acceptable locations.


While parents may have legitimate concerns about the safety of anesthesia for their young children, I think that a more active Dental Board could provide more appropriate reassurances.

Thank you for your letter describing the degradation of Sixteen Mile Creek and the unpleasant and unwholesome conditions occurring there. You are right to be upset that action addressing the root causes of the foul water and air is so long in coming.

North East, like many communities throughout the state, saw an increase in the number of homes and other facilities its sewage treatment plant services without providing for a concomitant increase in the sewage treatment plant's operating capacity. The most recent problem at the sewage treatment plant resulted both from human error and from retention on the site and in the system of more untreated and treated sewage sludge than the facility could handle. As you well know, conditions were so bad in mid-September that the facility was required to test its discharge for fecal coliform and for total suspended solids. The tests showed that the plant was operating in violation of its Department of Environmental Protection (DEP) issued discharge permits.

The factor that contributed to the plant's malfunctioning in this particular instance highlights a persistent problem for all of Pennsylvania as well as for North East. That is the disappearance of locations where surface application of treated sewage sludge is permitted. Reportedly, it was the decision of some landowners to no longer accept treated sludge from the treatment plant that led to the on site build up.

As a result of the treatment plant's violations of its DEP permit and of health code violations, the Borough of North East must make improvements to its sewage treatment plant. Likely improvements will be the purchase of more modern equipment that will reduce the bulk of processed sludge. Additionally, the plant will likely be required to increase its roster of workers and to improve their training to forestall a repeat of the

recent disastrous conditions prevalent in August and September.

Attached is a response to the Johnsons who are outraged at the conditions at the sewage treatment plant in North East. Department of Environmental Protection and the Department of Health were on top of the issue. Conditions there probably have existed for some time. It's a case of a municipality not wanting to or not having the money to upgrade its infrastructure, and to some extent being dependent on fewer and fewer local farmers who are still willing to accept sludge, resulting in an operators letting some untreated or only partially treated materials out. Sometimes heavy rains will cause an overflow to occur, but the event wouldn't happen if the facility didn't have more material on site than it should have.

It's really a development issue wherein more residents generate more waste at the same time they are forcing a decrease in acceptable land application sites, coupled with an unwillingness to pay more in taxes or in rates to keep an infrastructure capable of handling greater amounts of waste. The continuing problem is that even if North East gets a better plant, it, and all other sewage treatment plants, is still left with sludge, which, despite DEP's assurances that it's clean and fine, has a bad reputation.

Dear Ms. Clark:

Thank you for your letter expressing your deep concern about the effect of the present Congress on our environment. I share that concern and hope that you have contacted your Congressman and federal Senators to let them know how you feel.

Many state environmental laws must conform to federal law. For example, our clean water laws must at least be as stringent as federal laws. The Congress, supposedly in response to American taxpayers, are intent on dismantling government and the regulatory process through which laws are enforced. On the one hand, legislation is introduced that weakens existing regulation, and on the other, cuts in appropriations require agencies to cut staff. Both lines of attack result in the nonenforcement of laws.

Pennsylvania is also seeing some changes in the way environmental laws will be enforced. In response to a perceived need to trim agency budgets and to make the agency more user friendly, the Department of Environmental Protection, in developing new regulations, is delegating some permitting and enforcement activities to County Conservation Districts. We must watch the results of these activities over time to get a true picture of whether, and how, they affect the welfare of our environment.

Thank you for sharing your thoughts with me. Again, please contact your representatives to the United States Congress, as well. Do not hesitate to contact my office at any time to discuss issues of interest to you.
