Thank you for your recent letter in which you expressed your concern for the fate of the Health Care Cost Containment Council. As you mentioned, the Governor has asked that the health care data collection function of the Council be moved to the Pennsylvania Department of Insurance. Governor Casey claims this will streamline this function, costing the state less. However, he recently agreed to increase the Council's budget from \$900,000 to \$2 million, arguing that this will allow the expansion of the comparative data program to include reports of outpatient and physician services. The Council, on the other hand, claims it needs \$3.4 million to perform all of the functions the law mandates it to perform.

I certainly do not want any of the Council's many functions to be curtailed by the Governor's proposal. According to Ernest Sessa, the executive director of the Council, the average amount of money the Council has spent every year is approximately \$2.5 million. The legislature will have to determine whether or not it wants the Council to become enveloped by the Department of Insurance. Just as important, however, is the number of dollars that should be appropriated in order to perform these important functions.

I will certainly keep your views in mind as the legislature discusses this issue. I thank you again for contacting my office and for sharing your opinions with me.

Thank you for your letter regarding the need for more health care practitioners, primarily physicians, in Pennsylvania. For the past several years, the General Assembly has been studying the shortage of nurses in the state and physicians in very needy parts of the state, inner cities and rural areas for example.

I agree that a major area of cost containment in the health care industry comes through preventative treatment. If people have access to medical care, ailments can be treated at earlier stages with improved rates of recovery. Too many people delay treatment until the situation becomes critical, increasing the chances of serious complications and reducing the rate of recovery. The costs of treatment rise dramatically due to the seriousness of the illness and the extended period of recovery.

Both the Governor's budget and the House Democratic budget (which passed the House on May 19, 1992, with my support) included substantial funding increases to loan forgiveness and incentives for health care and family practice workers. The Health Care Loan Forgiveness and the Family Practice Incentive Program line-items were consolidated into the Family Practice and Health Loan Forgiveness program. An additional \$2,250,000 was appropriated under the House Democratic proposal for a total of \$3,000,000. I believe that we have demonstrated our commitment to quality and accessible health care despite the current budget restraints.

Although the \$3,000,000 appropriation is not the \$8,000,000 you requested, it is my sincere belief that these funds will be well-utilized. If I can be of any assistance to you in the future, please do not hesitate to contact my office.

Thank you for your recent letter in support of the Health Care Cost Containment Council.

In 1986 the Pennsylvania General Assembly chose a free market approach to contain health care costs in place of one of regulation. The framers of this legislation realized that this would be a difficult and time consuming task and allowed a five year time period for this process to take place. Some of the council's accomplishments during this period would include the implementation of a format for all health care providers and health care insurers to use in reporting data and the formulation of rules and regulations to collect and to protect the confidentiality of data.

In addition, the council conducted a 17 month study including 11 statewide hearings on problems of access to care for the medically indigent and submitted a report and follow-up studies to the Governor and the Legislature.

As you are aware, there is legislation before the Senate which would abolish the Health Care Cost Containment Council. The council's detractors cite what they claim as its (the council's) ineffective governance structure of the council itself.

Senate Bill 1519 was referred to the Public Health and Welfare Committee on March 15, 1990.

One of the most serious problems facing business today is the cost of providing health care benefits to employees and retirees. The rate of inflation for services provided by physicians and hospitals has been significantly above the rate of increases in the Consumer Price Index in recent years. In fact, the total cost of health care in this country has risen from approximately \$70 billion in 1970 to nearly \$650 billion in 1989. Continuing double-digit inflation for health care is projected for the foreseeable future.

Businesses across Pennsylvania are facing some very difficult decisions on how to handle this increasing liability. It is likely that a trend toward higher deductibles, fewer benefits and greater levels of cost-sharing for insurance premiums will become the norm. There are no easy answers to this dilemma and any solution will be the result of all of us doing what we can to reduce costs.

In 1986, the Legislature created the Pennsylvania Health Care Cost Containment Council (HCCCC). This Council was charged with creating a data base to provide health care users with important information on the quality and cost of various health care services provided by hospitals and clinics throughout the State.

I believe that one part of the solution will be for all users of the health care system to be more discriminating in choosing the services they need and what they are willing to pay for them.

I have seen the initial booklets published by the HCCCC for hospitals in Allegheny County, the Lehigh Valley and the Harrisburg area. The data is presented clearly and leaves no doubt concerning which hospitals are providing services at lowest cost and with acceptable or commendable quality. It is my understanding that the HCCCC will complete similar booklets for the balance of the State by March of 1991. As in any program which sets out to perform a difficult task, some of the data may be incomplete or may contain some inaccuracies. However, since the automated data gathering network has been created, it is clear that future editions of the reports will be more and more accurate and meaningful to the business community and their employees.

I've recently learned that there is a movement in Harrisburg (S.B. 1519) which would abolish the HCCCC. I'm writing to ask that you use your influence and cast your vote in a manner that the HCCCC is preserved, properly funded and able to complete its work as originally intended. Getting control of the high cost of health care is going to be the result of many people doing many things to attack the problem. As a businessman, I can think of few activities that are more important than providing a "consumer guide" for people who use the health care delivery system so that they can make informed judgments on where they seek medical help and how much they pay for it.

Please use your influence to retain and support the HCCCC as it completes its mission. The stakes are too high to allow a few special interest groups to derail the process which has been started.

Thank you very much for taking the time to write to me about your concerns in maintaining your health coverage for you and your husband. In an effort to be of assistance, I had my research staff look into the various options that could be available to you.

First, I would suggest that your husband contact his former employer to see if continued benefits coverage is available. In some cases, the former employee can enroll in continued insurance coverage at a cheaper group rate, rather than an individual rate.

Secondly, you may eligible for Medical Assistance. The Erie County Office of Assistance can determine eligibility and also provide information on other options and programs for the unemployed. The Corry Office phone numbers are 664-8644 or 1-800-635-1014.

And lastly, you indicated that you had pre-existing health conditions. Depending upon the pre-existing condition, you may be eligible for partial of full disability benefits. The Erie Social Security Administration can assist you in determining eligibility. Their number is 452-6696.

Unfortunately, your situation is quite common with others. In the past few months, I have received numerous questions and concerns from persons who have little or no health care insurance. President Clinton's recent health care reform plan has stimulated debate on health care reform. At every opportunity I have a chance to meet with people, I am repeatedly asked about what can be done to improve our health care system.

The General Assembly is in the beginning stages of addressing this issue. The House has already introduced the following health care bills: small business health insurance, cost control and consumer protection measures, affordability to poor families, accessibility in rural and medically underserved areas, managed care networks, single payer health care insurance, plus many other intiatives. page 2 Mary Ellen Jones October 12, 1993

It is worth noting that HB1958, the Governor's proposed Health Security Law, would establish a statewide health insurance system. This legislation is one of the many worthy and well thought proposals pending before the House. I have enclosed a copy of HB1958 for your perusal. As you will note, one of the intentions of this legislation is to guarantee access to each Pennsylvanian regardless of a change in or loss of their job. Also, I thought section 1911 which would establish the Health Security for Unemployed Pennsylvanians Program would be of interest to you. This legislation is being reviewed by the House Health and Welfare Committee.

Currently, the House Health and Welfare Committee is holding public input hearings on the various health care plans. This is a final series of public hearings that is expected to be completed by the end of this month. Eventually, this testimony will result in legislative action. As of this writing, I am reviewing HB1958, the various other proposed health care plans as well as the recommendations and comments presented to the Committee. You can be assured that I will remember you and your husband's situation as health care reform is deliberated in the General Assembly.

I sincerely hope this information is helpful. If in the coming weeks, you should have any questions or further require my assistance, please do not hesitate to write or call me.

Thank for you recent letter regarding Senator Corman's proposed amendment to Senate Bill 100. Your thoughts are welcomed and valued. I hope you will continue to contact me with your insights.

Senator Corman's amendment would allow an enrollee in a managed care plan the right to chose a non-participating provider for covered health care services. If the enrollee does chose a non-participating provider, the managed care plan shall reimburse the enrollee at a rate to at least eighty-percent of the payment the plan would have paid.

The House does not have the opportunity to vote on individual Senate amendments to bills. If the amendment is inserted in committee or passed by the Senate, it will be included in Senate Bill 100. If the Senate passes the bill, it will be brought before the House for consideration.

Senate Bill was referred to the Senate Public Health and Welfare Committee on February 25, 1997. The bill must be reported out of committee before it is considered by the Senate or the House. If you haven't already, you may want to contact the Senate Public Health and Welfare Committee Chairman:

At this time, may I urge you to support Senator Corman's amendment to SB100.


