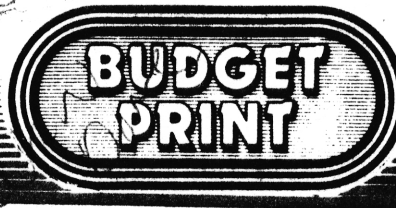

Within a month, November 8th to be exact, you will cast a critical vote that will be fundamental in continuing the role state government plays in your life. I ask for your vote on November 8th. It has been an honor for me to serve you and I look forward to continued service. Your support and encouragement are important to me.



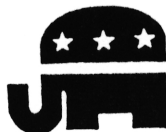

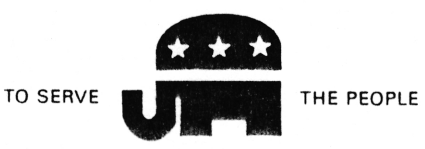
I am announcing my candidacy for a seventh term to represent the 156th legislative district in the state House of Representatives. This district is composed of East Goshen, West Goshen, West Whiteland, Uwchlan townships and West Chester.

For the past eleven years I have been your Representative . . . your voice in state government. For you I have taken my job seriously. None of your problems have been too small or too large, and I have handled them promptly, thoughtfully, and with action. On a daily basis, since the day I was sworn into office your problems have been mine.

The following constituent comment was one of the factors in my decision to run for a seventh term and, thus, to renew my commitment to you . . . "You have met all challenges with courage. Your demonstrated wholehearted responsiveness to constituent need has, indeed, proven you to be untiring in your devotion to the 156th district as a full-time public servant."

I keep in touch by means of newsletters and questionnaires. My visits to the schools, businesses and public service meetings allow me to create a two-way means of communication. I write a bi-weekly column for the Suburban Advertiser. To assist my constituents in resolving many problems relating to state government and its agencies, I maintain an office at 13 W. Miner Street, West Chester.

I am pleased and proud to place before you my legislative record . . . a record earmarked with fiscal conservatism, protection of local controls, concern for taxpayers' dollars, limitation on government spending and a love of God and my Country.

I am a member of the Education Committee. As Republican Chairman of the House Subcommittee on Higher Education for the past 10 years, I am sensitive not only to quality education, but also to affordable education for the college students and in public education also affordable to the taxpayers. In this key position I respond to all facets of higher education in the Commonwealth. College costs must be made affordable and colleges and universities must be held accountable. I am proud to note that Pennsylvania is among the leaders in education in the United States. Education is the "Keystone" of our Commonwealth. As Franklin Delano Roosevelt said "We can not build the future for our children but we can build our children for the future."

I am an active member of the Board of Directors of the Pa. Higher Education Agency (PHEAA), which sets administrative policies for state financed student financial aid programs for the entire state. My initiative - Scholars in Education Award (SEA) - was adopted by PHEAA to address the serious shortage of teachers of math and science in Pa. schools. This is a true scholarship in that it rewards a student's scholastic achievement. Two West Chester University students received this award in 1987. I was the prime sponsor of the Parent Loan Program for Undergraduate Students (PLUS) which enables parents to borrow money at reduced interest rates. The first PLUS loan was made to a West Whiteland family. As a result of my activity in the PHEAA Board, I have been prime sponsor of other legislation which provides low interest loans to students from middle-income families. These loans are made at no cost to the Commonwealth. My student loan legislation is effective in that 16.1 M has been collected by wage garnishment of defaulters. 176 M is the total collected from loan defaulters.

As a senior member of the Health & Welfare Committee, I consistently support legislation to assist senior citizens by insisting that lottery money be used in senior citizen programs - i.e. co-pay prescription plan which requires senior citizens to pay only \$4.00. This program is for seniors with incomes less than \$12,000. for a single person and \$15,000. for a couple. I propose to raise these limitations to \$15,000. and \$20,000. Other programs supported by me with funding from the lottery are \$10.00 car registration, transportation accommodations and the tax or rent rebate program. I was a key speaker at the rally in Philadelphia which called for a better understanding of the mentally ill and proper care for these who are mentally ill. The signing into law of the Health Care Cost Committee was a major step toward quality health care. Currently, I am a member of the Select Committee on Long Term Care. This is an issue that faces many families and must be faced and resolved as soon as possible.

Having been active in the passage of legislation to keep drunk drivers off the road and to require child restraint seats in automobiles, I continue to help stop the carnage and loss of life on the roads by supporting seat belt legislation. All literature and statistics state that "seat belts save lives". Opponents argue that it is an invasion of privacy. However, in a letter written to me by a child (who wears a seat belt), the child implored me to help pass a law so his parents would wear their seat belt. My only disappointment in the Pa. law is that I would have preferred a stronger bill but it is a step in the right direction. The serious problems that the disease AIDS presents to our society must be solved. The sex-education guidelines that have caused concern among parents and education have been withdrawn by the Dept. of Education. I was active in addressing this issue.

A major area of interest to me is children. As a member of the Children's Caucus, Gov. Casey's Task Force on Child Day Care, I am active in seeing that all children receive proper health care. My H.B.189 (1987) provides exemption from state income tax for child care expenses utilized by working parents.

I support efforts for the protection of children from abuse and to ensure that child support payments are made on a timely basis by the absent parent. My concentrated efforts have been in moving my latchkey legislation which supports the use of public schools for these programs. The legislation does not mandate establishment of extended day care programs and the cost would be on the ability of the parent to pay. It is not free child-care but my legislation is received as meeting a need for supportive child care service through better use of existing facilities. Even though my legislation moves slowly through the legislative process it has been successful in highlighting and has drawn public attention to the needs of the latchkey child. There are more than 6.5 million latchkey children across the country and up to 120,000 in Pennsylvania - children age 5 - 12.

As your representative - I am your lobbyist - our lobby may not be organized officially and we don't have any money, but we - you and I - have our purposes, our issues and our platform. But more than that we have determination, courage and commitment to move ahead to build a future for ourselves and those who come after us that represents a decent, wholesome quality of life.

My commitment is to serve the people with integrity, honesty and personal involvement. As a Republican legislator, my record is earmarked as one of dedication, leadership and effective representation. My slogan - "She cares, listens, and acts" is not mere rhetoric, not a "catchy" slogan and not an idle promise but rather it has withstood the test of time and it is my sincere pledge that has been and will be honored.





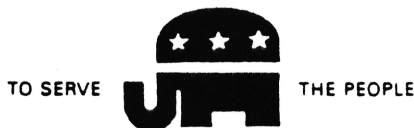
