



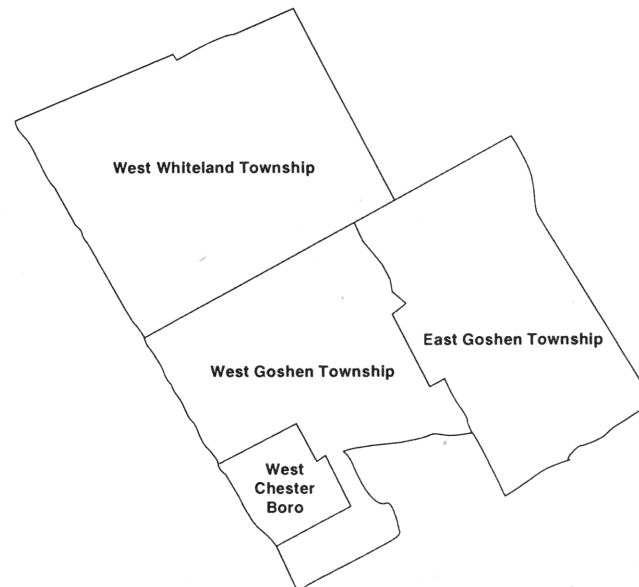

Earlier this year I had the opportunity as your State Representative to welcome you, a new resident, to my legislative district.



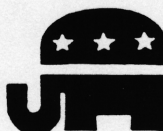

I take this opportunity to thank you for signing my petition. As you know, this is the first step in the process of my name being placed on the ballot for election.






My legislative offices have provided you with service. I trust you were pleased with the service you received and hope you will continue to utilize this valuable resource whenever the need arises.

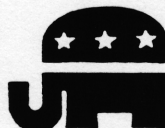

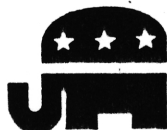
