- ..... distributing copies of state highway maps and maps indicating the location of all state parks and recreation areas;

Additionally, please be reminded that my office can provide information on possible tours of the Capitol, Governor's Home or State Museum. Each year numerous groups from the 156th District make the trip to Harrisburg to enjoy these features.
