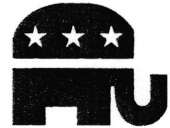


I want to thank you for lending your name to be my **1998** Campaign Chairman. I deeply appreciate your willingness to be a part of the 1998 campaign and value your friendship.

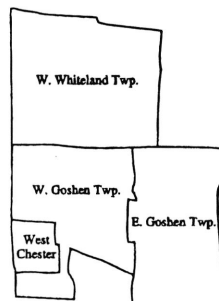
I know that I can count on you to continue to offer advice and counsel in the 200 campaign and that we will work together for a Republican victory in 2000.

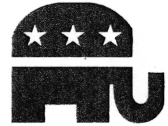

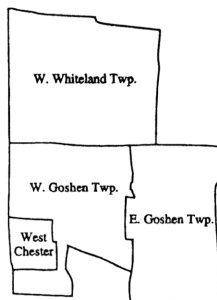
I ask for your endorsement. Please let me know if you have any questions or concerns, I desire your input not only on campaign issues but on legislative issues as well.

Elinor Taylor says, "It is important to me, to the constituents in the 156<sup>th</sup> district and to the future generations that we elect capable, caring, committed government officials."

With this thought in mind, she is announcing her candidacy for re-election to the Pennsylvania House of Representatives for the 156<sup>th</sup> District, composed of East Goshen Township, West Whiteland Township, the Borough of West Chester, and portions of West Goshen Township. Elinor pledges to continue the high quality of constituent service and legislative representation which have been the hallmark of her political career.

"Election 2000 will not be business as usual," Taylor said. "I will look to the future with innovative solutions to old, nagging problems and address vigorously new issues."

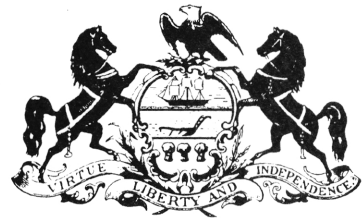
I am also interested in learning your thoughts and views on any legislative issue. In short, I'm always interested in hearing from you. My door is always open.
