The Economic Impact Study states that "West Chester University hopes to continue to generate \$90M in annual economic benefits to Chester County". It also reports that West Chester University costs the local government sector approximately \$8M. The report acknowledges that "costs and benefits can not be quantified". The benefits of living in a college town include cultural, educational, and sports events sponsored by the university and a better-educated labor pool for local businesses.


In an effort to address the University's costs to the community, I prime sponsored HB 594, PN 349 on March 2, 1999. This legislation was reported out of the Education Committee May 8, 2000. The bill authorizes agreements between SSHE and local municipalities providing for payments to local fire and emergency services. It also includes a state appropriation. The bill was laid on the table October 2, 2000.

I believe the college has a responsibility for the conduct of students living in the borough and that accommodations for campus living must be a part of plans for university growth.

I can promise to work with your group and others towards resolution of problems that confront a college community. I do not believe in division, (i.e. "us" and "them" approach), but rather I look forward to an opportunity to work together toward reasonable solution.
