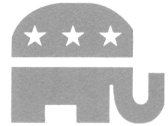

Dear Mr. and Mrs. Leicht:

It is my pleasure to inform you that today House Bill 656, requiring reimbursement of diabetic supplies, was signed by Governor Tom Ridge. It is now Act 98 of 1998. This law shall take effect in 120 days from October 16, 1998.

House Bill 656 mandates that all individual and group health insurance policies provide coverage of **diabetes** equipment - including glucose monitors, monitor supplies, insulin, injection aids, syringes, insulin infusion devices, pharmacological agents for controlling blood, and orthotics.

Thank you for informing me of your views on this important issue. If I can be of further assistance on any other state-related issue, please do not hesitate to contact my office.

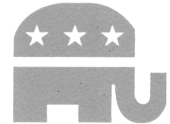

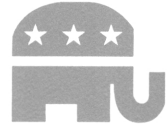

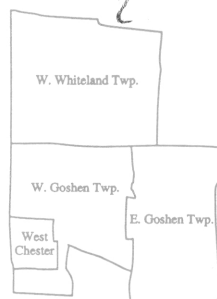
I am anxious to meet with the committee again. I would like to bring you up-to-date on the progress of the campaign. I would also like to seek your input on several issues. Our agenda will include:

With the primary election moved up to April 4th the timing for getting signatures seemed short and was hampered by our recent "blizzard."

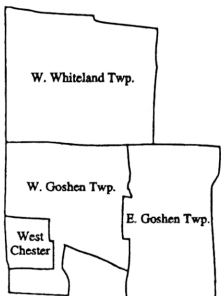
I was pleased that over 40% of my committee men and women participated in the process of obtaining signatures. I am fortunate to have such a commitment from friends and committee people.

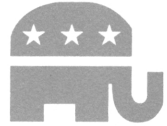

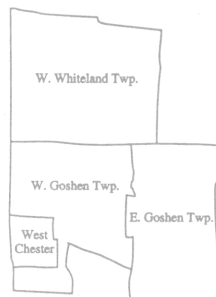
