## Semmel Resolution Calls for Study of Rifle and Shotgun Use In High Population Areas

HARRISBURG – Working to improve public safety and prevent accidental shootings during hunting season, Rep. Paul Semmel (R-Leigh/Burks) has House approval of a measure designed to study the use of rifles and shotguns.

As a result of Semmel's legislation, the Legislative Budget and Finance Committee will now conduct a study on the use of rifles and shotguns in special regulated areas within the Commonwealth, particularly populous areas of the southeast and southwest.

"This study will give us the information we need to determine if special regulation areas for using rifles and shotguns should be expanded in the Commonwealth," said Semmel. "In November a mother-to-be was shot and nearly killed. This is a matter that needs to be looked into to prevent such incidences from ever happening again."

The Legislative Budget and Finance Committee will contract with an independent risk assessment specialist to conduct the study in coordination with the Pennsylvania Game Commission.

The Pennsylvania Game Commission determines the type of firearms or bow and arrows and the type of ammunition that hunters may use in designated areas of the state based on public safety and the proper management of game animals and game birds.

The resolution also requires that the Legislative Budget and Finance Committee prepare oral and written reports within 180 days of the adoption of the resolution, which is to be presented to the Game and Fisheries Committee of the House of Representatives.

The Game and Wildlife Code provides the Game Commission with the authority to define geographic limitations, determine type and number of devices to be used in game and wildlife activities, and to collect, classify, and preserve data to be used by the Game Commission.

"This terrible incident reflects a serious problem that continues to grow as urban and suburban expansion increases in many areas of the state," said Semmel. "This study will provide us with some

much-needed information on the use of hunting firepower in populated areas and I am looking forward to reviewing the results of the report."

Semmel's resolution passed the House on March 30.
