In my capacity as Chairman of the House Veterans Affairs and Emergency Preparedness Committee, I would like to respectfully request that Adjutant General William B. Lynch be afforded the opportunity to address the House of Representatives on the House floor at the beginning of session on October 1, 2001. On this day, the Pennsylvania National Guard will be conducting their "Legislative Day at the Capitol" and there will be numerous displays and events throughout the Capitol complex.

With this in mind, it would indeed appear appropriate to have Adjutant General Lynch provide the members with a 15-minute update on the current status of our National Guard, coupled with important details on the October 2002 deployment of approximately 900 Pennsylvania National Guard troops to Bosnia. This Pennsylvania unit will be the command element of the United States peacekeeping force in that region.
