We are writing to request the assistance of the Berks County Intermediate Unit in disseminating information to the eighteen school districts and, if possible, the non-public schools you also serve. The information enclosed with this letter pertains to a project which we are supporting, to raise funds to preserve the monuments at the Gettysburg National Park which commemorate the valiant efforts of Berks County veterans.

An elementary class in the Wilson School District has raised some funds to put toward this effort. We are hoping their example may stimulate other schools to make a similar contribution. We are pleased that the Berks County Community Foundation has agreed to match the school students' donations which will be put toward restoration and maintenance. It is estimated that \$6,000 is needed for this purpose. Additional funds will be used to create an endowment for the preservation program.
