SUBJECT: Reintroduction of Legislation

FROM: Representative Larry O. Satherfary O. Sather

When we return to session, I plan to reintroduce legislation (previously HB1081) which unanimously passed the House on October 5th, but unfortunately did not get through the Senate procedure before the end of session.

I am introducing this legislation again in response to the recognition within the medical and adoption communities that knowledge of family medical histories is vitally important for the long-term health of every individual.

Most of us are able to obtain this information, but adoptees can't be assured that they have all of the information because Pennsylvania's current adoption law doesn't account for situations where natural parents remember or find out about this information after the adoption's finalization.

While maintaining the confidentiality of the birth parent, my bill would insure that family medical history information about the natural parents include that which may be relevant to a potential hereditary or congenital medical problem reaches the adoptee whenever this information becomes known. The adoption community is supportive of this concept and recognizes the need for this amendment to the current law.

WHAT THIS BILL WOULD DO

House Bill 215 will amend the adoption act to require that medical information be provided about the natural parents whether or not this information is in existence or discoverable at the time of adoption regarding potential medical, hereditary or congenital problems.

This bill would require the department of welfare upon request to make available to courts, adoption agencies, and individuals, forms that enable parents who's rights have been terminated to register and update medical history information with the department and, with the court which entered the decree of termination. The department of Health will develop the content of the medical history information forms in consultation with the department of public welfare.

This medical history information will be edited before release by the department of Public Welfare to the adopted person. This editing will remove any information which would identify the adoptee's natural family.

WHY THIS BILL IS GOOD

We have the ability to enact legislation that would immediately make adifference in people lives immediately. There are many children

and adults in Pennsylvania who's lives may be saved or changed for the better if they were to receive relevant health information.

This information is needed today not next year or next session.



HARRISBURG -- Attempting to further encourage preventive health care, Rep. Larry Sather this week introduced legislation amending the medical history provisions of Pennsylvania's adoption laws.

"With every medical science and technical advance, it is becoming apparent that the more information known about a person's medical history, the better the odds for preventing and treating serious hereditary and genetic health conditions," Sather said.

"Consequently, I have sponsored House Bill 1081 to require that medical history information about the natural parents which may be relevant to any potential hereditary or congenital medical problem be provided by the attending physician or other designated person to the adopting parents or their physician," he said.

The condition need not be in existence or discoverable at the time of adoption. The bill does not affect the confidentiality of the natural parents.

"Adopted children need information about hereditary medical conditions which may not be evident until they reach adulthood. This type of information can be very helpful in preventing or treating future health problems," the Blair and Huntingdon counties lawmaker said.

Sather said the bill has the support of over 22 bipartisan cosponsors.
